SUBJECT: ESTABLISHING THE ORDER OF APPOINTMENT OF THE VICE-

MAYOR AND SELECTING AND DESIGNATING DISTRICT 5

COUNCILMEMBER, STEVE LUSTRO, AS VICE-MAYOR

#### **RECOMMENDATION:**

It is recommended that the City Council adopt the following resolution:

RESOLUTION NO. 2025-35—A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, ESTABLISHING THE ORDER OF APPOINTMENT OF VICE-MAYOR AND SELECTING AND DESIGNATING DISTRICT 5 COUNCILMEMBER, STEVE LUSTRO, AS VICE-MAYOR

**PREVIOUS RELATED ACTION:** On June 17, 2024, the City Council adopted Resolution No. 2024-91 (Attachment 2) establishing the order of appointment of Vice-Mayor, selecting and designating Councilmember Nora Garcia, as Vice Mayor.

### **DISCUSSION:**

## **●**Eight-Month Vice-Mayor Selection Cycle

Pursuant to Section 2-41(a) of the Pomona City Code (PCC), the City Council shall select one of its members as Vice-Mayor every eight months. Additionally, PCC Section 2-41(e) requires that newly elected Councilmembers be added to the bottom of the list in descending numerical order, therefore Council districts 1 and 6 are placed at the end of the list.

Accordingly, it is recommended that the City Council adopt the attached Resolution No. 2025-35 (Attachment 1) establishing the order of appointment as Districts 5, 4, 6, 1, 2 and 3; that District 5 Councilmember Steve Lustro be appointed as the current Vice-Mayor; and the order for appointment for the next eight-month term beginning October 20, 2025, be Districts 4, 6, 1, 2, 3 and 5.
