

HPC RESOLUTION NO. 25-042

**A RESOLUTION OF THE HISTORIC PRESERVATION
COMMISSION OF THE CITY OF POMONA, CALIFORNIA,
DETERMINING THAT THE PROPERTY LOCATED AT
1760 CORDOVA STREET IS NOT HISTORIC**

**THE HISTORIC PRESERVATION COMMISSION OF THE CITY OF POMONA
DOES RESOLVE AS FOLLOWS:**

WHEREAS, the applicant, Rodd Golshan, submitted an application for Determination of Historic Significance (DHS-000611-2025) to determine the historic significance of the property located at 1760 Cordova Street;

WHEREAS, the property was constructed 1959;

WHEREAS, the Historic Preservation Commission must make findings as described in Section .800.C.(2) of the Pomona Zoning & Development Code to make a Determination of Historic Significance;

WHEREAS, the Historic Preservation Commission of the City of Pomona, has, after giving notice thereof as required by law, held a public meeting on December 3, 2025, concerning the requested Determination of Historic Significance (DHS-000611-2025); and

WHEREAS, the Historic Preservation Commission has carefully considered all pertinent testimony and the staff report offered in the case presented at the public hearing.

NOW THEREFORE, BE IT HEREBY RESOLVED by the Historic Preservation Commission of the City of Pomona, California, as follows:

SECTION 1. Based on the policies contained in the Pomona General Plan and Historic Preservation Ordinance, the Historic Preservation Commission concludes as follows:

1. Preserving Pomona's diverse architectural styles reflecting phases of the City of Pomona's history and encouraging complementary contemporary development inspires a more livable urban environment;
2. Pomona's historic places should be preserved to build civic pride by promoting the understanding, appreciation, and enjoyment of the city's rich heritage and cultural resources;
3. Preserving Pomona's historic places enhances property values and increase economic and financial benefits to the City;
4. Preserving Pomona's historic places enhances the City of Pomona for residents, tourists and visitors thereby stimulating business and industry; and

5. Preserving Pomona's historic places conserves valuable material and energy resources by fostering ongoing use and maintenance of the existing built environment.

SECTION 2. In view of all of the evidence and based on the designation criteria contained in the staff report, the Historic Preservation Commission concludes as follows:

The property located at 1760 Cordova Street does not meet the National Register of Historic Places, California Register of Historical Resources, and/or the City of Pomona designation criteria as contained in the City's Historic Preservation Ordinance, and therefore, is not historic.

SECTION 3. All documents described in Section 1 of Historic Preservation Commission Resolution No. 25-042 are deemed incorporated by reference as set forth at length.

SECTION 4. The Secretary shall certify to the adoption of this Resolution and forward the original to the City Clerk.
