## A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING APPENDIX B OF THE MEMORANDUM OF UNDERSTANDING WITH THE POMONA CITY EMPLOYEES' CHAPTER OF THE TEAMSTERS LOCAL 1932 BY ADDING VARIOUS CLASSIFICATIONS

**WHEREAS,** the City Council has the authority to create, classify and assign salary scales/ranges for all City of Pomona classifications;

WHEREAS, on December 11, 2023, the City Council adopted Resolution No. 2023-244 adopting the 2023-2027 Memorandum of Understanding (MOU) between the City of Pomona and the Pomona City Employees' Chapter of the Teamsters Local 1932 (PCEA/Teamsters), which also established a Roster of PCEA General Service classifications; and

**WHEREAS**, in order to meet department staffing needs, the City Council desires to amend Appendix B of the aforementioned PCEA MOU by adding the classifications of Senior Plans Examiner and Stormwater Maintenance Crew Leader.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona, California, as follows:

**<u>SECTION 1</u>**. That the City Council hereby authorizes an amendment to Appendix B of the PCEA/Teamsters MOU by adding the following classifications:

| Classification                     | Scale  | Step 1 | Step 2 | Step 3 | Step 4 | Step 5 |
|------------------------------------|--------|--------|--------|--------|--------|--------|
| Senior Plans Examiner              | GS-076 | 9,189  | 9,645  | 10,129 | 10,635 | 11,166 |
| Stormwater Maintenance Crew Leader | GS-054 | 5,336  | 5,602  | 5,884  | 6,178  | 6,481  |

**<u>SECTION 2</u>**. That any portion of previously adopted Resolutions concerning salaries inconsistent with this Resolution shall be deemed repealed.

**SECTION 3.** The action approved herein shall become effective July 13, 2025.

**SECTION 4.** The City Clerk shall attest and certify to the passage and adoption of this Resolution and it shall become effective immediately upon its adoption.
