Subject: Adoption of a Resolution Accepting the State of California's Alcoholic

Beverage Control (ABC) Mini Grant and Amending the FY 2017-18

Special Revenue Operating and Revenue Budgets

OVERVIEW

Recommendation – That the City Council adopt a resolution:

- 1. Accepting the State of California's Alcoholic Beverage Control (ABC) Mini Grant and agreeing to the terms and conditions of the Grant Agreement; and,
- 2. Amending the FY 2017-18 Police Department expenditures and revenues for grant funds to receive \$21,000 for the ABC Mini Grant.

Fiscal Impact – The fiscal impact is neutral due to an increase in the operating budget expenditures of \$21,000 (215-2090-XXXXX-58678), with a corresponding offsetting increase of \$21,000 in grant revenue (215-2090-40873-58678).

Public Noticing Requirements – None required.

Previous Related Action – The City Council accepted the State of California 2015 ABC Mini Grant on November 2, 2015.

EXECUTIVE SUMMARY

Action on this item is to accept a State of California Alcoholic Beverage Control (ABC) Grant for Local Law Enforcement Agencies, in the amount of \$21,000 awarded to the Pomona Police Department. The ABC grant provides funding to law enforcement agencies to focus on identified high crime areas and/or areas that have identifiable alcohol-related problems associated with licensed alcoholic beverage establishments.

DISCUSSION

The goal of the State of California's ABC grant is to enable selected law enforcement agencies to expand their efforts in addressing alcohol-related problems through a comprehensive ABC program that will encompass a wide range of strategies. The grant provides funding for an 11-month period beginning October 1, 2017 and continuing through August 31, 2018. All ABC grant enforcement operations will be performed on an overtime basis and will be conducted in cooperation with the local ABC District Office. These efforts will include: Minor Decoy Operations (where a minor enters a business and attempts to purchase alcohol) and Shoulder Tap Operations (which focus on adults who purchase alcohol for minors). The main focus of the grant is to reduce alcohol-related offenses in the City, and to reduce alcohol sales to minors. Also, LEAD (Licensee Education on Alcohol and Drugs) training will be available to educate licensees and their employees on how to safely, responsibly and legally serve alcoholic beverages at their establishments while discouraging illicit drug use. As such, with the acceptance of this new mini-grant, the following amendments to the Police Department's FY 2017-18 operating and revenue budgets are therefore requested:
