

RESOLUTION NO. 2025-112

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, TO AMEND THE FY 2025-26 CAPITAL IMPROVEMENT PROGRAM (CIP) BUDGET BY CREATING TWO NEW PROJECTS, “PALOMARES PARK SOCCER FIELD REHABILITATION,” PROJECT NO. 428-2590-XXXXX-71129 AND APPROPRIATING \$50,561 OF DISTRICT 6 CIP CARRYOVER DISCRETIONARY FUNDS TO THE PROJECT, AND “WESTMONT PARK RESTROOM REHABILITATION,” PROJECT NO. 428-2590-XXXXX-71130, AND APPROPRIATING \$17,688 OF DISTRICT 5 CIP CARRYOVER DISCRETIONARY FUNDS TO THE PROJECT, CLOSING AN UNFUNDED PROJECT, “CIVIC CENTER TILE REHABILITATION,” PROJECT NO. 428-2590-XXXXX-71126, CLOSING AND UNAPPROPRIATING \$40,000 OF DISTRICT 5 COMMUNITY DEVELOPMENT BLOCK GRANT FUNDING FROM “WESTMONT PARK SOFTBALL FIELD REHABILITATION,” PROJECT NO. 428-2590-XXXXX-71120 AND CLOSING THE PROJECT, AND APPROPRIATING THIS FUNDING AND \$636,636 OF COMMUNITY DEVELOPMENT BLOCK GRANT FY 2025-26 ALLOCATIONS TO VARIOUS PROJECTS AS DETAILED IN EXHIBIT A

WHEREAS, the City Council desires to provide for the rehabilitation of the Palomares Park soccer field;

WHEREAS, the City Council desires to provide for the rehabilitation of the restroom at Westmont Park and \$40,000 of Community Development Block Grant Funding (CDBG) is available to unappropriate from “Westmont Park Softball Field Rehabilitation,” Project No. 428-2590-XXXXX-71120 thereby closing the Project;

WHEREAS, the City Council desires to close the unfunded Project “Civic Center Tile Rehabilitation,” Project No. 428-2590-XXXXX-71126 and provide for Civic Center tile rehabilitation as part of its Project, “Civic Center Plaza – New Playground and Amenities,” Project No. 428-2590-XXXXX-71063; and

WHEREAS, the City Council desires to appropriate an additional \$636,636 of FY 2025-26 CDBG allocations to various projects as depicted in Exhibit “A” of the Resolution.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. The City Council amends the FY 2025-26 CIP Budget by creating a new CIP project, “Palomares Park Soccer Field Rehabilitation,” Project No. 428-2590-XXXXX-71129.

SECTION 2. The City Council amends the FY 2025-26 CIP Budget by creating a new CIP project, “Westmont Park Restroom Rehabilitation,” Project No. 428-2590-XXXXX-71130.

SECTION 3. That the City Council amends the FY 2025-26 CIP Budget by re-appropriating \$40,000 of District 5 CDBG funds from CIP 71120 to CIP 71130, and appropriating \$636,636 of FY 2025-26 CDBG Allocations, \$50,561 of District 6 Carryover Discretionary Funds, and \$17,688 of District 5 CIP Carryover Discretionary Funds as detailed in “Exhibit A.”

SECTION 4. The City Clerk shall attest and certify to the passage and adoption of this Resolution, and it shall become effective immediately upon its approval.
