ORDINANCE NO. 4335

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING CHAPTER 58 ("TRAFFIC AND VEHICLES"), ARTICLE III ("VEHICLE OPERATION"), SECTION 58-122 ("SPEED LIMITS FOR SPECIFIC STREETS") OF THE POMONA CITY CODE BY UPDATING THE SPEED LIMITS ON DESIGNATED CITY STREETS FOR YEARS 2023 AND 2024

WHEREAS, State Law requires that speed limits on certain types of roadways be updated every seven to ten years in order to maintain proper enforceability; and

WHEREAS, an Engineering and Traffic Survey (E&TS) was conducted for all required roadway segments within the City; and

WHEREAS, this survey included the review and applicability of recent updates under Assembly Bill (AB) 43, with priority given to streets with a history of fatal and severe injury collisions; and

WHEREAS, the City desires to adopt lower speed limits on applicable streets as recommended in the E&TS.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Pomona as follows:

SECTION 1. That Pomona City Code, Chapter 58, Traffic and Vehicles, Article III, Vehicle Operation, is hereby amended as follows:
