

RESOLUTION NO. 2023-84

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING THE FY 2022-23 CAPITAL IMPROVEMENT PROGRAM (CIP) BUDGET BY CHANGING THE PROJECT DESCRIPTION AND TITLE FOR “ENERGY EFFICIENCY UPGRADES – POMONA PUBLIC LIBRARY AND PALOMARES PARK COMMUNITY CENTER,” PROJECT NO. 428-2590-XXXXX-71077, AND RELEASING AND UNAPPROPRIATING \$1,029,831 OF SOCALREN REVOLVING SAVINGS FUND LOAN PROCEEDS**

**WHEREAS**, the City Council desires to change the title and project description for “Energy Efficiency Upgrades – Pomona Public Library and Palomares Park Community Center,” Project No. 428-2590-XXXXX-71077 to remove the Pomona Public Library from the title and the project description.; and

**WHEREAS**, any Library-related upgrades previously included in “Energy Efficiency Upgrades – Pomona Public Library and Palomares Park Community Center,” Project No. 428-2590-XXXXX-71077, are now included in “Pomona Library Facility Improvements,” Project No. 428-2590-XXXXX-74120.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona as follows:

**SECTION 1.** The City Council amends the FY 2022-23 CIP Budget by changing the title and description of “Energy Efficiency Upgrades – Pomona Public Library and Palomares Park Community Center,” Project No. 428-2590-XXXXX-71077, as follows:

- a. Revising the project title to remove the Pomona Public Library; new project title is “Energy Efficiency Upgrades – Palomares Park Community Center,” Project No. 428-2590-XXXXX-71077; and
- b. Removing the scope of work related to the Pomona Public Library from the project description.

**SECTION 2.** The City Council amends the FY 2022-23 CIP Budget by:

1. Unappropriating \$1,029,831 of SoCalREN Revolving Savings Fund Loan Proceeds from “Energy Efficiency Upgrades – Pomona Public Library and Palomares Park Community Center,” Project No. 428-2590-XXXXX-71077 (428-2590-66196-71077; 428-2590-80482-71077).

**SECTION 2.** The City Clerk shall attest and certify to the passage and adoption of this Resolution, and it shall become effective immediately upon its approval.
