POMONA VALLEY TRANSPORTATION AUTHORITY SERVICE AND COST INCREASE DISCUSSION

Introduction

- Created in 1977 and includes the Cities of Pomona, Claremont, La Verne, and San Dimas
- Provide Paratransit Services to seniors and persons with disabilities
- Provides these services through Get About, Claremont Dial A Ride, San Dimas Dial A Cab, Pomona Group, Ready Now, and One Step Over The Line



Services Offered for Pomona Residents

- Get About and Get About Extended:
 - Provides transportation at a low cost (currently \$1.00 one way per trip) for seniors and persons with disabilities throughout the service area. Get About Extended provides this service for \$2.00 a one way trip more west to Glendora and Covina.
- Ready Now
 - Provides for a taxi/Uber model for residents where they can call and request a ride for \$4.50.
- One Step Over the Line:
 - Provides for trips outside of the immediate service area into San Bernardino County for medical visits.
- Pomona Group:
 - Provides service for youth groups and after school recreational programs in the City of Pomona

Pomona Riders


- Serve approximately 700 Pomona individual residents a year with mobility and non-mobility issues.
- "Mobility" includes riders that use mobility devices such as wheelchairs, canes, walkers, oxygen, and service animals.

• About 70 percent of trips are considered "essential" trips, such as trips to the doctor.


Pomona Riders

• Many riders use Get About daily or more than once a day. One resident has used Get About over 1,000 times in FY 2024-25

- Costs are based on proportionate City usage and Pomona's usage comprises the highest share of costs, mainly attributable to Get About
- Pomona Impact \$2 Million Increase from FY23 levels

Revenue Sources


- Los Angeles County Metro Proposition A:
 - Prop A is City's main source of funding for PVTA services.
 - The City receives approximately \$4 million in revenue from Prop A
 - Utilized at City's two transit stations as well as PVTA

City of Pomona's Share of Get About Increases Over the Last Three Years



• In FY 2024-25, PVTA entered into a new service agreement and increase reflects only 8 months of service agreement as well as PVTA's covering increases with fund reserves.

 Get About Service Reduction: The current level of service among the four member Cities provides for approximately 28,000 revenue hours which equates to approximately 90,000 one way trips. Proposed to reduce to 15,000 revenue hours, which would reduce available trips by approximately ¹/₂.

- Eliminate the One Step Over the Line Service:
 - The Program is costly and alternatives are available and can be coordinated with PVTA's mobility manager. For example, Get About and Ready Now can transport users to the Montclair Transfer Center or the Montclair Mall where they can connect with San Bernardino County's Access Program.

• Raise Fares to be more in line with Los Angeles County Metro's Access Program
