Mayor Sandoval presented the proclamation to Chara Swodeck from the African American Advisory Alliance, who spoke a few words about the history of Kwanzaa in Pomona.

**MAYOR/COUNCILMEMBER COMMUNICATIONS**

Councilmember Martin gave thanks to the Downtown Pomona Owners Association and volunteers for putting together the Downtown Christmas Parade. Councilmember Martin also thanked Garey High School Music Department for putting on the Christmas Orchestra Concert and thanked the Music Director for giving Councilmember Martin the Lifetime Achievement Recognition for the Arts. Lastly Councilmember Martin asked for crosswalk guards in front of a few schools in the City.

Councilmember Preciado attended the Downtown Christmas Parade and the Garey High School presentation. Councilmember Preciado would be visiting some elementary schools dressed as Santa Claus and wished everyone happy holidays.

Councilmember Garcia commented on the challenges of the year and the opportunities for compassion and kindness that opened up. Councilmember Garcia also announced upcoming events in the community: Santa and Grinch at the Library and several toy drives.

Vice Mayor Ontiveros-Cole discussed the Downtown Pomona Christmas Parade, touched on some of the tragedies around the world, and discussed the importance of mental health.

Councilmember Lustro announced the upcoming e-waste event hosted by Los Angeles County and discussed concerns about graffiti on unused train cars near Valley Blvd.

Dear City Councilmembers,

My name is Taylor Dang and I believe our city's social host ordinance for alcohol should be amended to include other illicit substances such as tobacco.

We are all well aware of the dangers that these substances pose to people, such as increased risks of car crashes, assault, addiction, and ultimately the loss of a family member.

Additionally, we also seem to have bad reputation for it. When I mentioned I was from Pomona to a college classmate, they said it was where they got their weed from. I know that we don't want our city's reputation to be a place where young people, especially those under the legal age, can get these substances.

The current social host ordinance fines adults who distribute alcohol to the youth through parties and gatherings. Why are we financially reprimanding adults for the illegal distribution of alcohol? This also means that we then "encourage" the distribution of other more toxic and dangerous substances. Safety and accountability should be increased with a social host ordinance that includes more illicit drugs and substances.

I want to be proud of our city, not fearful of the lives that could be destroyed through it.

Thank you for considering my comment, I truly believe you will choose to act and make this city better by amending the social host ordinance.
