SUBJECT: AMENDMENT TO THE FY 2025-26 OPERATING BUDGET ADJUSTING

REVENUE ESTIMATES AND APPROPRIATIONS FOR THE

HOMELESS PROGRAM'S BUDGET

RECOMMENDATION:

It is recommended that the City Council adopt the following resolution:

RESOLUTION NO. 2025-111 – A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AUTHORIZING THE AMENDMENT OF THE CITY OPERATING BUDGET BY AMENDING REVENUE ESTIMATES AND APPROPRIATIONS

EXECUTIVE SUMMARY:

Annually, the Housing Stabilization Division administers and implements over 15 different grants totaling \$10 million in program funds. As the fiscal year ended, staff identified unexpended funds budgeted for various activities in FY 2024-25 that must be appropriated in FY 2025-26 for expenditure authority. These funds come from programs that were not fully expended during the previous fiscal year and grant awards that cross multiple fiscal years and must be carried over. Additionally, various other grants had expenditures occur after the FY 2025-26 City Operating Budget was created and requires a reduction in revenue and appropriations to reflect the accurate program balance. This report requests fund balances be appropriated in the FY 2025-26 City Operating Budget.

FISCAL IMPACT:

The adoption of Resolution No. 2025-111 (Attachment No. 1) will amend the FY 2025-26 Operating Budget by adjusting revenue estimates and appropriations per the chart below. Amendments to accounts are based on remaining balances for each program and eligible funds to be carried over from FY 2024-25.

DISCUSSION:

The City of Pomona currently receives Measure H, Continuum of Care (CoC), Emergency Solutions Grant (ESG), and Miscellaneous State funds from different agencies as follows: Department of Housing and Urban Development (HUD), Los Angeles Homeless Services Authority (LAHSA), and County of Los Angeles. At the close of FY 2024-25, various funding sources had unexpended fund balances, including Miscellaneous State and County of Los Angeles funds. These funds need to be appropriated in FY 2025-26 for expenditure authority. Unexpended funds and program income will be used for projects and activities that are eligible under each funding source and currently administered by the City.

COUNCIL PRIORITIES & GOALS:

This supports the FY 2021-22 City Council Priority 1: Fiscal and Operational Responsibility – Goal C: Obtain additional grant funding and other revenues to help achieve City goals.
