5. CANCELLATION OF THE DECEMBER 12, 2024, VEHICLE PARKING DISTRICT BOARD OF PARKING PLACE COMMISSIONERS COMMISSION MEETING

Commissioner Mladinov motioned to approve the above subject item, the cancellation of the Vehicle Parking District Board of Parking Place Commissioners December 12, 2024, commission meeting. STAFF COMMUNICATION

Economic Development Director Kirk Pelser updated the Commission on the Lot 10 parking garage, stating that an architectural contract was signed and a kick-off meeting was held. The consultant has commenced their investigative/background work for the project. Mr. Pelser affirmed that Downtown stake holders will have the opportunity to review and comment on the project. Staff will work with the DPOA to coordinate those meetings. Mr. Pelser further mentioned that there is the possibility to utilize some of the City "Development In-Lieu Art Fee" for the arts community perhaps for City art staff office space.

Commissioner Garcia Juarez asked from where the "Art Fee" is derived. Mr. Pelser explained that a 1% art in-lieu fee based on the value of the new development is collected to provide public art.

Economic Development Director Kirk Pelser, informed the Commission concerning Lots 6 and 7 that the Planning Department is still negotiating with the developer's architect on the design and state housing requirements applicable to the project.

Senior Project Manager Joaquin Wong provided an update on the improvements to the ADA parking spaces in the VPD lots. He indicated that the RFP for engineering / survey / design service has gone out on planet bid to all the City's pre-qualified on call engineers and that the bids are due back later in October. Economic Development Director Pelser, clarified that the bids would be for design services and once completed those document would be utilized to obtain actual construction bids for the work (A separate RFP). Mr. Wong further stated that if the bids come in over \$150,000, it would require City Council approval which is an additional step to the overall process.

COMMISSIONER COMMUNICATION

Commissioner Mladinov reminded the Commission that DPOA Christmas Parade is coming up and to sign up with the DOPA if anyone is interested in participating. The parade date is December 14, 2024.

Commissioner Mladinov stated that the Tessiers have art work that they would like to donate and install in the VPD parking lots and they should call Joaquin for the process. Economic Director Kirk Pelser indicated that the City has an adopted process for public art installation and it's not through Joaquin, It is through the Planning Department and Arts Commission. The Tessiers are familiar with process. Vice-Chair Hemming reiterated that the Tessiers are very familiar with the process. Commission Mladinov indicated that he would relay that message to the Tessiers.
