Robert Scheppmann, Sgt. Pomona PD Fatal Traffic Collisions – Data and Statistics are based on:

Substance abuse information determined by police investigation or by coroner's report 2001-2023

Data of fatal collisions in Pomona compared to other southern California cities of similar geographical size and population

100 fatal traffic collisions

Since 2017 an uptick of hit and run and vehicle vs. vehicle Bicyclist/pedestrians

Time Categories – 2017-2023

6:00 am – noon Noon to 6:00 pm 6:00 pm to midnight – spike in traffic collisions Midnight to 6:00 am

Gender/Race

More men involved on the road and involved in traffic collisions; higher number of male Hispanics But consistent with demographics

Substance by Type

DUI Investigation or Coroner's report

Alcohol and drugs consistent through the years; most of the investigations have not been include due to the fact toxicology reports have not been received

Causes of Collision

Turning Movements Other failed to Yield Speed Violations DUI Pedestrian Violations

Pomona Residents Involved

Numbers a bit skewed due to the number of people involved in traffic collision 38 total people involved in traffic collisions - 17 are residents and 21 live outside of the city

Beat 1 - N of Mission/West of Garey/South of 10Fwy- high vehicle/pedestrian traffic

Beat 2 - N of 10 Fwy/streets near Garey/ Foothill Blvd/ Towne Ave

Beat 3 – East of Garey Ave/North of tracks/South of 10 Fwy

Beat 4 – South of tracks/East of Garey Ave

Series of high fatal traffic collisions on:

Mission: Pedestrian involved fatalities

Reservoir/Towne: Numerous fatal collisions

RELATED CITY PROJECTS PLANNED STARTED COMPLETED

Paving/striping of roadways to make more visible to see Installation of raised medians and curb extensions; sidewalk extends out to prevent vehicles from making a turn at the red light Installation of class 4 bike lanes Signal Upgrades

All projects considered a road diet

Location Analytics

Occur in areas of: Main traffic thoroughfares; high volume of vehicles High population density near the main streets Higher speed limits with open design

Q: Is there a breakdown between Pedestrian vs. Bicyclists?

A: Bicyclist almost considered as a pedestrian; skateboarders, non-motorized scooters

Q: Correlation higher fatalities near bars while intoxicated

A: not to his knowledge

Q: Is J Walking no longer illegal?

A: J-Walking is no longer a violation; pedestrian responsibility still in the code

Vice-Chair Oliva

Q: Railways being looked at for public safety, any information related to those studies?

A: no direct knowledge

Q: Any data on people running red lights?

A: Slight increase in red light violations on Towne Ave and Benita/Indian Hill – San Bernardino Q: Data on 2nd/Garey Ave southbound?

A: 30 MPH is the legal speed; vehicles are speeding at 50 MPH and don't have enough time to slow down or stop

Commission Ellis-Royston

Q: Male Female and Other?

A: Any other gender identification that would be in a traffic collision report address non-binary, transgender or any other gender that could be included

Q: Do any of the fatal collisions have to do with street conditions?

A: Sunrise/sunset/moon phases/lighting conditions/ambient lighting caused by business neon signs

Q: Anything being done about the heavily congested rea on Holt

A: Email Sgt. with your questions

Q: Will this presentation being given to City Council?

A: It was last year
