A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING THE FY 2023-24 CAPITAL IMPROVEMENT PROGRAM (CIP) BUDGET BY ACCEPTING STP-L GRANT FUNDS AND REIMBURSEMENT FUNDS, INCREASING REVENUE ESTIMATES, AND APPROPRIATING \$450,000 OF FEDERAL STP-L GRANT FUNDS AND \$68,716 OF REIMBURSEMENT FUNDS FROM THE CITY OF LA VERNE, CALIFORNIA, AND UPDATE THE PROJECT DESCRIPTION FOR "STREET PRESERVATION – CITYWIDE (FY 16-17) (MAJOR)," PROJECT NO. 428-2590-XXXXX-67920

WHEREAS, the project description in the FY 2023-24 CIP Budget for "Street Preservation – Citywide (FY 16-17) (Major)," Project No. 428-2590-XXXXX-67920, Federal Project No. STPL-5070(041) states that there is Federal STP-L supplemental funding pending approval for the Project; and

WHEREAS, the City of Pomona has requested federal aid in the form of STP-L funding for the completion of the Project; and

WHEREAS, the City of Pomona has allocated the required STP-L matching local funds for said Project; and

WHEREAS, the City of Pomona wishes to allocate reimbursement funds from the City of La Verne, CA, for shared improvements to the said Project.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. That the City Council amends the FY 2023-24 CIP Budget by accepting grant funds, increasing revenue estimates, and appropriating \$450,000 of Federal STP-L funds to "Street Preservation – Citywide (FY 16-17) (Major)," Project No. 428-2590-XXXXX-67920 (428-2590-66196-67920; 428-2590-40875-67920).

SECTION 2. That the City Council amends the FY 2023-24 CIP Budget by accepting reimbursement funds from the City of La Verne (pending the City of La Verne's approval of the agreement with), increasing revenue estimates, and appropriating \$68,716 of funds received from the City of La Verne to "Street Preservation – Citywide (FY 16-17) (Major)," Project No. 428-2590-XXXXX-67920 (428-2590-66196-67920; 428-2590-40915-67920); and updating the Project description to include, "Phase 2 of Project: Rehabilitation of White Avenue from Gate 5 of the Fairplex to Arrow Highway."

SECTION 3. The City Clerk shall attest and certify to the passage and adoption of this Resolution, and it shall become effective immediately upon its approval.
