**PUBLIC COMMENT**

Public Speaker Mayra Langarnica discussed past interactions with Code Compliance and Pomona Police.

**INSPECTOR GENERAL COMMUNICATION**

Stephen Connoly confirmed the Inspector General's office was following the investigation that had been assigned to the Inspector General's office last month.

Chair Russell asked about the Police Oversight's Commission ability to weigh in on the Internal Affairs investigation before a decision is rendered.

Mr. Connoly stated his understanding of the Commission's role is that once IA completes their investigation, it is then provided to the Inspector General's office. The IG's office then prepares a report for the Police Oversight Commission and from there the Commission may make recommendations to the Police Department.

Chair Russell requested that the IG's office and herself research the Commission's role and discuss further at next month's meeting.

**STAFF COMMUNICATION**

Police Chief Ellis announced a promotional process had been completed and introduced Captain Alyssa Bostrom and Captain Deon Brown. Captain Brown would also now be the official PD liaison to the Police Oversight Commission. Lastly, Chief Ellis invited the commissioners to attend the upcoming promotion ceremony.

Commission Secretary Robles recommended agendizing the selection of a Chair and Vice Chair for the meeting in February as is required of every commission per the standard commission by-laws.

**COMMISSIONER COMMUNICATION**

Commissioner Yanez requested agendizing a report-out from the PD Monthly Reports Ad-Hoc committee for the meeting in February.

**MOTION BY CHAIR RUSSELL, SECOND BY VICE CHAIR BROOKS, CARRIED 4-0 (COMMISSIONER GIBANI ABSTAINED), to agendize a report-out from the PD Monthly Reports Ad-Hoc committee for the meeting in February.**

Chair Russell discussed the need to push the presentation of the Annual Report to City Council to the second meeting in February and would like the Annual Report Ad-hoc committee to present a draft version of the report to the Police Oversight Commission before presenting it to City Council.

Commissioner Gibani expressed support for Chair Russell's recommendation.

City Clerk Butler confirmed the Annual Report presentation scheduled for the January 26, 2026 City Council meeting would be moved and re-scheduled to the February 23, 2026 City Council meeting.

**MOTION BY CHAIR RUSSELL, SECOND BY VICE CHAIR BROOKS, CARRIED 4-0, to agendize a review of the draft Annual Report for February's meeting and schedule the presentation of the Annual Report to City Council on February 23, 2026.**

Chair Russell gave an update on the Day of Prayer and Empowerment and discussed the importance of collaborating with neighborhood stakeholders, such as churches, to address sex trafficking crimes.

Commission Secretary Robles asked if the Commission would be agendizing the selection of a Chair and Vice Chair for next month's meeting.
