

## RESOLUTION NO. 2025-22

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AUTHORIZING THE ACCEPTANCE OF \$90,627 IN MEASURE H HOMELESS INITIATIVE FUNDS TO LOCALLY ADMINISTER THE HOMELESS INCENTIVE PROGRAM (HIP) AND THE AMENDMENT OF THE FY 2024-25 OPERATING BUDGET BY INCREASING REVENUE ESTIMATES AND APPROPRIATIONS BY \$3,633**

**WHEREAS**, on June 13, 2017, the Board of Supervisors (“Board”) approved funding allocations for each of the Measure H eligible Homeless Initiative strategies that included an allocation to Los Angeles County Development Authority (“LACDA”) (formerly known as HACoLA) for Strategy B4 – “Facilitate Utilization of Federal Housing Subsidies”; and,

**WHEREAS**, LACDA received Homeless Initiative, Strategy B4 Funding (the “Funding”) from the County of Los Angeles (“County”) and awarded Measure H funding to the City of Pomona Housing Authority (“PHA”); and,

**WHEREAS**, the PHA became a sub-recipient of funds to implement the Homeless Incentive Program (HIP) to assist homeless individuals and families with a Housing Choice Voucher with move-in costs and provide incentives to landlords to accept tenants with a voucher issued by the PHA; and,

**WHEREAS**, the amendment to the agreement for FY 2024-25 saw an increase in funding at the request of the PHA to assist additional voucher holders.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona as follows:

**SECTION 1.** Approve the acceptance of \$90,627 in Measure H Homeless Initiative Funds to help house fifteen homeless individuals and families, which includes \$9,062 (139-1702-XXXXX-65401) for administrative costs and \$81,565 (139-1791-XXXXX-65401) for program operations.

**SECTION 2.** Amend the FY 2024-25 Neighborhood Services Department operating budget by increasing revenue estimates and appropriations by \$3,633.
