

RESOLUTION NO. 2025-127

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA AMENDING FY 2025-26 CAPITAL IMPROVEMENT PROGRAM (CIP) BUDGET BY INCREASING REVENUE ESTIMATES AND APPROPRIATIONS BY A TOTAL OF \$458,569 OF LOS ANGELES COUNTY METROPOLITAN TRANSPORTATION AUTHORITY PROPOSITION C FUNDING AND APPROPRIATING THIS FUNDING TO “STREET REHABILITATION – DISTRICTS 2 AND 3,” PROJECT NO. 428-2590-XXXXX-67935

WHEREAS, due to a corrective action issued by the Federal Government to Caltrans and Southern California Association of Governments related to the allocation methodology for Surface Transportation Block Grants – Surface Transportation Program - Local (STP-L) funding, Metro will be replacing the Pomona allocation with Prop C Funds; and

WHEREAS, to effectuate this, the City Council desires to enter into an agreement with Los Angeles County Metropolitan Transportation Authority (Metro) to receive Proposition C Funding in the amount of \$458,569 to replace those STP-L funds; and

WHEREAS, the City desires to amend the FY 2025-26 CIP Budget by increasing revenue estimates and appropriations by \$458,569 of Metro Proposition C funding and appropriating this funding to “Street Rehabilitation – Districts 2 and 3” Project No. 428-2590-XXXXX-67935.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. The City Council amends the FY 2025-26 CIP Budget, increasing revenue estimates and receiving and appropriating \$458,569 of Metro Proposition C funding by appropriating this funding to “Street Rehabilitation – Districts 2 and 3,” Project No. 428-2590-XXXXX-67935 (217-2590-40825-67935, 217-2590-89987-67935, 428-2590-80736-67935, and 428-2590-66196-67935).

SECTION 2. The City Clerk shall attest and certify to the passage and adoption of this Resolution, and it shall become effective immediately upon its approval.
