

RESOLUTION 2023-106

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING THE CITYWIDE SALARY SCHEDULE FOR FISCAL YEAR 2022-23 TO MEET THE CALIFORNIA CODE OF REGULATIONS TITLE 2, SECTIONS 570.5 AND 571 IMPLEMENTING A 2.5% SALARY INCREASE**

**WHEREAS**, the City Council has the authority to create, classify and design salary scales for all represented and unrepresented classifications for the City of Pomona;

**WHEREAS**, California Code of Regulations (CCR) Title 2, Section 570.5 and 571 requires a consolidated Salary Schedule that is publically available showing all City classifications and salary ranges;

**WHEREAS**, the City Council wishes to maintain compliance with these regulations by amending the Citywide Salary Schedule for Fiscal Year 2022-23, which sets forth the salary scales/ranges for all City of Pomona employee classifications;

**WHEREAS**, the City Council wishes to amend the Citywide Salary Schedule for Fiscal Year 2022-23, previously adopted by City Council Resolution No. 2022-96 on June 9, 2022 and amended by Resolution Numbers 2022-124, 2022-151, 2022-169, 2022-232, 2023-32, 2023-46; and 2023-62; and

**WHEREAS**, “Exhibit A” includes a two and one-half percent (2.5%) general salary increase effective retroactively to October 9, 2022 for full-time classifications and January 15, 2023 for part-time classifications.

**NOW THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona, California as follows:

**SECTION 1.** That the City Council hereby amend the Salary Schedule for all City of Pomona classifications as set forth in the attached “Exhibit A” to reflect two and one-half percent (2.5%) general salary increase.

**SECTION 2.** The salaries approved herein shall become effective retroactively as listed in “Exhibit A” under the Effective Date for each classification.

**SECTION 3.** The City Clerk shall certify to the passage and adoption of this resolution, and it shall become effective immediately upon its adoption.
