A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AUTHORIZING A SIDE LETTER AGREEMENT TO THE 2021-2023 MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF POMONA AND THE POMONA MID-MANAGEMENT/CONFIDENTIAL EMPLOYEES' ASSOCIATION (PMMCEA) IMPLEMENTING A 2.5% SALARY INCREASE

WHEREAS, the City Council has the authority to create, classify and assign salary scales/ranges for all City of Pomona classifications;

WHEREAS, on October 18, 2021, the City Council, adopted Resolution No. 2021-141 adopting the 2021-2023 Memorandum of Understanding (MOU) between the City of Pomona and the Pomona Mid-Management/Confidential Employees' Association (PMMCEA);

WHEREAS, the 2021-2023 MOU, Article V. Section A. Salary, includes provisions of negotiated salary increases; and

WHEREAS, the City Council authorizes the City Manager to negotiate and enter into a Side Letter Agreement with PMMCEA to amend Article V. Section A Salary, to add a two and one-half percent (2.5%) salary increase retroactive to October 9, 2022.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona, California as follows:

SECTION 1. That the City Council hereby authorizes the City Manager to negotiate and enter into a Side Letter Agreement in "Exhibit A" that provides a two and one-half percent (2.5%) general salary increase retroactive to October 9, 2022.

SECTION 2. Approve the amendment to the 2021-23 PMMCEA MOU regarding a two and one-half percent (2.5%) salary increase retroactive to October 9, 2022.

<u>SECTION 3</u>. The City Clerk shall attest and certify to the passage and adoption of this resolution, and it shall become effective immediately upon adoption.

Side Letter Agreement to the 2021-2023 Memorandum of Understanding between The City of Pomona and Pomona Mid-Management/Confidential Employees Association (PMMCEA)

This Side-Letter of Agreement is entered into by and between the City of Pomona and the Pomona Mid-Management/Confidential Employees Association (PMMCEA) and is effective upon the execution of both parties and adoption by the City Council.

WHEREAS, the City realized a budget surplus in fiscal year 2022-2023; and

WHEREAS, the City extended and the Union accepted a two and one-half percent (2.5%) salary increase. This action by the City Council recognizes the dedication of all current PMMCEA employees as negotiations for a successor Memorandum of Understanding (MOU) begins.

WHEREAS, the City Council approved amending the 2021-23 PMMCEA MOU, Article V. Section A. Salary to add a two and one-half percent (2.5%) salary increase retroactive to October 9, 2022; and

WHEREAS, the City and PMMCEA met and conferred regarding this increase;

Now therefore the parties agree as follows:

- 1. That the salary schedule for all employee classifications in PMMCEA shall be increased by 2.5% retroactive to October 9, 2022;
- 2. That nothing in this agreement shall be considered precedent-setting or establish a past practice;
- 3. All other terms and conditions of the current MOU between the parties shall remain in effect.
