

**RESOLUTION NO. 2025-78**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA  
APPROVING THE CLOSURE OF CITY HALL DURING THE 2025  
HOLIDAY SEASON AND CANCELLATION & RESCHEDULING OF  
2026 MEETING DATES DUE TO CONFLICTS WITH OBSERVED  
HOLIDAYS**

**WHEREAS**, Section 503 of the Pomona City Charter requires that regular meetings of the City Council be established by ordinance or resolution; and,

**WHEREAS**, the City Council adopted Resolution No. 2004-32, which establishes the first and third Monday of each month for regular meetings and the second Monday of each month for Study Sessions, as necessary; and,

**WHEREAS**, the City Council adopted Resolution No. 2023-155, which establishes that the City Council goes “dark” for the second regularly scheduled meeting in August; and,

**WHEREAS**, due to holidays and other scheduling conflicts that fall on the same day as regularly scheduled meetings, it would be in the best interest of the City to cancel and reschedule certain regular meetings in order to allow the efficient conduct of the City’s business; and,

**WHEREAS**, the City Council desires to modify the annual City Council meeting schedule, authorize the closure of City Hall during the 2025 Holiday Season and to cancel and reschedule regular meetings as listed below in the 2026 Calendar Year that conflict with recognized City holidays or other scheduled events.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona as follows:

**SECTION 1.** The City Council hereby authorizes the closure of City Hall from to Wednesday, December 24, 2025 – Thursday, January 1, 2026, to avoid staffing shortages during the 2025 Holiday Season.

**SECTION2.** The regular City Council Meeting scheduled for January 19, 2026, is hereby cancelled and rescheduled to Monday, January 26, 2026, to be conducted as a regular meeting of the City Council.

**SECTION 3.** The regular City Council Meeting scheduled for February 16, 2026, is hereby cancelled and rescheduled to February 23, 2026, to be conducted as a regular meeting of the City Council.

**SECTION 4.** The regular City Council Meeting scheduled for September 7, 2026, is hereby cancelled and rescheduled to September 14, 2026.

**SECTION 5.** All other City Council Meeting dates established in accordance with Resolution No.2004-32 and 2023-155 remain unchanged unless otherwise rescheduled by resolution.

**SECTION 6.** The City Clerk shall attest and certify to the passage and adoption of this resolution and it shall become effective immediately upon its approval.
