## **RESOLUTION NO. 2022-163**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING THE FY 2022-23 OPERATING BUDGET BY INCREASING APPROPRIATIONS BY \$236,792 FROM EXISTING PUBLIC ART FUND RESERVES TO ACCOUNT FOR PUBLIC ART ACTIVITIES AND APPROVING EXHIBIT A: LIST OF CALL FOR VISUAL ART AWARDEES

**WHEREAS,** the City issued a Call for Visual Art in March 2022 with the intent of funding public art citywide;

**WHEREAS,** the Cultural Arts Commission, in consultation with its Citizen's Advisory Committee, has approved a list of awardees to fund for public art from the Public Art Fund, as listed in Exhibit A;

**WHEREAS**, the cumulative total of projects identified in Exhibit A exceeds \$150,000, and fiscal best practice is to have the City Council review and approve the award;

**WHEREAS**, City Council must approve to amend the FY 2022-23 Operating Budget by Increasing Appropriations estimates by \$236,792;

**WHEREAS**, pursuant to the Pomona City Charter requires that amendments to the Adopted FY 2022-23 Fiscal Budget be approved by City Council by Resolution.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona as follows:

<u>SECTION 1</u>. The FY 2022-23 City operating budget is hereby amended to reflect changes to revenue budget and appropriations as follows:
