Veteran Pete Garcia led the Pledge of Allegiance to the Flag.

**PRESENTATIONS**

A. Presentation by Pomona Chamber of Commerce

Sandra Vaughan-Acton and Erica Frausto provided a presentation to the City Council regarding the fiscal year activities of the Chamber of Commerce, and provided updates to the City Council on their past inquiries.

B. Present Certificates of Recognition for Los Angeles Regional Agency Award Winners for Recycling

Mayor Sandoval explained that the recipients had been awarded the 2018 San Gabriel Valley Environmental Award by the Los Angeles Regional Agency. The following were recipients of the award:

**MAYOR/COUNCILMEMBER COMMUNICATIONS**

Councilmember Torres thanked the City Manager and staff for responding to various requests that had come from the community meetings in District 6. He reported that he had attended a Fairplex Strategic Planning meeting and that it had been very productive. He stated that he was looking forward to working with Fairplex to accomplish the plans.

Councilmember Ontiveros-Cole reported on the following events: Mayor's Prayer Breakfast, Kingsley students City Hall tour, Memorial Day Ceremony, American Legion Barbeque, St. Madeline's Festival, Gary High School ROTC ceremony, and the Pomona Youth Orchestra concert.

Vice Mayor Gonzales thanked the Pomona Police Department for the work they had done to

rescue a 15 year-old girl from sex trafficking and the Mexican Mafia arrests. He thanked the Mayor and the Police Department for the work that was being done to abate prostitution in the City. He reported on various events and activities that he had been involved in. He commented on the students that had recently graduated and was encouraged to see them staying in the community.

Councilmember Carrizosa reported on the various events and activities that she had been involved in. She encouraged everyone to attend the Pomona Band and the Pomona Youth Orchestra concerts.

Mayor Sandoval thanked those that had organized the Mayor's Prayer Breakfast. He announced that Fuller Seminary would be moving to Pomona from Pasadena, and that the move would bring 3,000 to 4,000 students and approximately 1,000 staff to the City. He reported that he had attended the Muslim ceremony in Chino which had included individuals from various faiths.

### **CITY MANAGER COMMUNICATIONS**

City Manager Lowry stated that she did not have anything to report.

### **PUBLIC PARTICIPATION**

Douglas C. Pierce, Pomona resident, commented on the California Governor's race and the illegal confiscation of property.

Holly Reynolds, Director of The Learning Center at Fairplex, announced that the Fairplex Strategic Plan had been unveiled earlier that day, and that it was available on the Fairplex website. She noted that the process for putting the plan together had been rewarding with many from the community participating. She stated that August 31, 2018, would be Pomona Day at the Fair and that admission tickets would be \$1 for Pomona residents.

Victor Caceres, Executive Director of the Youth and Family Club, reported that there were 150 youth on the first day of the summer program, and that they expected that number to increase to over 300 by the following week. He invited everyone to the monthly Friends Luncheon on Thursday, June 7, 2018 at 11:30 a.m.

Pedro Martinez, Pomona resident, commented on an issue he was having with the Housing Department regulations, and requested assistance.

Maryann Higgins, Pomona resident, encouraged the City Council to keep funding for the Pomona Public Library in the budget. She noted that the Library played a vital role in the community.

Horatio Ruiz, Sacred Heart Church board member, expressed concern with the number of street vendors that had been crowding the entrances and exits of the church parking lot. He noted that the church served over 4,000 parishioners every weekend, and stated that it was a

safety issue. He requested assistance to resolve the issue.

Angela Magana and members of the Pomona Valley NAACP Chapter, invited everyone to attend the June 23, 2018 Forty Day Call to Action Rally at City Hall from 1:00 to 3:00 p.m. in support of the Poor Peoples Campaign.

Eunice Russell, Pomona resident, stated that there were a number of safety issues on Val Vista Street with people speeding to get on the Freeway, hit and run accidents, and burglaries. She requested assistance from the City to address the various problems.

Pete Garcia, Pomona resident, noted that the issue regarding street vendors needed to be addressed. He stated that a number of veterans were trying to restart the Veterans of Foreign Wars (VFW) program in Pomona. He noted that they were looking at a building on Second Street, and requested assistance from the City Council to help them secure the use of the building.

Alecia Lopez, Tobacco Control and Prevention Director for Day One, requested that the City Council prioritize discussion of the draft Tobacco Retail Licensing ordinance.

Deborah Clifford, Historical Society of Pomona Valley President, commented on the history of the City,

Randy Beckendam, Pomona resident, invited everyone to the re-launch of the Pomona Farmers Market on June 16, 2018 from 7:30 to 11:30 a.m. in the parking lot of Purpose Church. He noted that they had invited 20 new organic vendors, and that the bulk of the produce would be grown in Pomona.

Elinor Crescenzi, Pomona resident, commented on the need to work together for the good of the community. She encouraged the City Council to support the Farmers Market, and noted that the produce would be high quality with low prices. She invited everyone to participate in the relaunch of the Farmers Market on June 16, 2018.

Councilmember Carrizosa and Escobar stated that they would also contribute an amount to be determined. Mayor Sandoval stated that he would speak with Councilmember Robledo regarding her participation in the request.

Councilmember Escobar requested that Item B be added to the Finding of Public Benefit as it had come up after the posting of the agenda, and that the item needed immediate action. She stated that she would be covering the entire cost of the event, if there was agreement to add the item to the agenda.

### **PUBLIC HEARINGS**

9. Presentation and Discussion on Proposition 64, the Medicinal and Adult-Use Cannabis Regulation and Safety Act, Additional State Laws and Emergency State Regulations; and Request to Obtain Direction from City Council

City Attorney Alvarez-Glasman, Norma Kapata, and Assistant City Attorney Jared provided a Power Point presentation regarding the various laws and options for regulating commercial cannabis businesses. Assistant City Attorney Jared provided information regarding the ballot initiative that had been submitted to the City Clerk to allow commercial cannabis sales.

Following the presentation, by consensus of the City Council the Public Hearing was opened.

Michael Coleman stated that several new marijuana impact reports would be issued in the next few months, and indicated that he would provide those to the City Council, should they request them. He advised that it was important to understand the differences and regulations regarding the medical use of marijuana and the recreational use of marijuana.

Christopher Kim, Pomona resident stated that the proposed ordinance was poorly written. He noted that Pomona should be a model for other cities regarding the look of the business, and the laws and regulations regarding marijuana.

Eunice Russell, Pomona resident, expressed support for legal marijuana dispensaries and associated businesses. She stated that the City should start with a couple of legal dispensaries, and then increase the number as regulations were fully implemented.

Dr. George expressed support for the presentation and recommendations provided by the City Attorney's staff.

Mark Ramos, President of the UFCW 1428 in Claremont, California, said that the union helped to provide good jobs and safety for the community. He stated that a weighted, merit-based application system was the best option, and, that once the application had been submitted, there should be no lobbying of the City Council.

Pam, a public health professional, noted that a merit-based system would provide the best option for operators to work in collaboration with the City. She noted the need for cannabis education to ensure public safety and consumer safety, and include information on the laws and regulations, plant science, history, safe access and use.

Adam expressed support for a merit-based application system, and stated that it would bring the best applicants with the best business practices to the City.

City Attorney Alvarez-Glasman clarified that the maps included in the ballot initiative discussion had been provided by the proponents of the initiative, and were not proposed by staff.

Following Public Comments, by consensus of the City Council, the Public Hearing was closed.

Discussion ensued regarding mechanisms for community education, licensing requirements by the State and other entities, creation of incentives for high quality businesses, background check requirements, zoning requirements, development agreements and conditional use permits, application fees, merit based application system, sensitive use locations, vending machine and event/festival regulations, limitations on the number of licenses to be issued, social costs to the community, taxation on marijuana sales, lobbying by potential business owners, and benefits to the community. There was further discussion regarding funding for enforcement, community outreach programs, preventative measures, youth programs, after school programs, at-risk youth programs, drug prevention education, infrastructure, parks and community centers. There was also discussion regarding the language of the ballot measure that had been submitted to the City Clerk, as it related to the proposed ordinance.

The City Council requested Staff to bring back a checklist of key topics for the City Council to consider in the drafting of the potential marijuana ordinance for consideration at the June 18, 2018.

Mayor Sandoval requested that the Budget presentation be provided to all the City Commissioners, and asked that staff coordinate scheduling of that presentation.


**ADJOURNMENT**
