## **RESOLUTION NO. 2025-65**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING THE FY 2024-25 CIP BUDGET BY INCREASING REVENUE ESTIMATES AND APPROPRIATIONS BY A TOTAL OF \$29,400: \$19,000 OF METROPOLITAN WATER DISTRICT MEMBER AGENCY ADMINISTERED PROGRAM FUNDING TO THE "HYDRATION STATIONS UPGRADES" PROJECT NUMBER 528-2590-XXXXX-71073, AND, \$10,400 FROM THE SOUTHERN CALIFORNIA GAS COMPANY TO THE "WATER RESOURCES BUILDING" PROJECT NUMBER 575-8125-XXXX-93135; AND, UN-APPROPRIATE AND APPROPRIATE VARIOUS WATER AND SEWER CIP PROJECTS FUNDING AS DETAILED IN EXHIBIT A, PRIORITIZING EXPENDITURE OF VARIOUS AVAILABLE BOND PROCEEDS

**WHEREAS**, the City Council has prescribed the authority by Charter of the City of Pomona to adopt and amend the Capital Improvement Program (CIP) budgets;

**WHEREAS**, the Metropolitan Water District (MWD) is offering grant funds for the Member Agency Administered Programs (MAAP) in the amount of \$19,000; funding into the "Hydration Stations Upgrades" project number 528-2590-XXXXX-71073;

WHEREAS, the Southern California Gas Company (SoCalGas) and the City have entered into a Settlement Agreement which stipulates the "rent payment" of \$800 per month while SoCalGas is actively working on the Water Yard cleanup; estimated to be in the amount of \$10,400; into the "Water Resources Building" project number 575-8125-XXXXX-93135;

**WHEREAS**, the projects listed in the attached "Exhibit A, Section 1 and Section 2" are included in the FY 2024-25 Capital Improvement Program (CIP) budget;

**WHEREAS**, the City Council desires to un-appropriate Bond Proceeds as found in "Exhibit A, Section 1" from the various CIP Projects and appropriate the available and unexpended bond proceeds totaling \$406,358 as detailed in the attached "Exhibit A, Section 2"; and,

**WHEREAS**, the City Council desires to un-appropriate and appropriate bond proceeds, Water Fund Balance and Sewer Fund Balance as presented in "Exhibit A, Section 1 and Section 2".

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona as follows:

**SECTION 1.** The City Council hereby amends the FY 2024-25 CIP Budget, by increasing revenue estimates and receiving and allocating \$19,000 from the MWD reimbursable grant MAAP and \$10,400 in rent payment revenue from SoCalGas as detailed in Exhibit A, Section 2.

**SECTION 2.** The City Council hereby amends the FY 2024-25 CIP budget by unappropriating various Bond Proceeds funding and Water and Sewer funding as detailed in Exhibit A, Section 1.

**SECTION 3.** The City Council hereby amends the FY 2024-25 CIP budget by appropriating various bond proceeds, Water Fund Balance and Sewer Fund Balance for CIP projects as detailed in "Exhibit A, Section 2", attached hereto.

**<u>SECTION 5.</u>** The City Clerk shall attest and certify to the passage and adoption of this Resolution, and it shall become effective immediately upon its approval.
