

RESOLUTION NO. 2025-18

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING THE FISCAL YEAR 2024-25 OPERATING BUDGET BY UNAPPROPRIATING \$5,950 OF GENERAL FUND PARKS AND LANDSCAPE MAINTENANCE FUND SALARY SAVINGS AND AMENDING THE FISCAL YEAR 2024-25 CAPITAL IMPROVEMENT PROGRAM (CIP) BUDGET BY APPROPRIATING THIS \$5,950 OF SALARY SAVINGS TO “SKATE PARK AT KENNEDY PARK,” PROJECT NO. 428-2590-XXXXX-71102

WHEREAS, pursuant to the Pomona City Charter, amendments to the Adopted FY 2024-25 Operating Budget require approval of the City Council by Resolution; and

WHEREAS, as allowed by the City’s Charter, the recommended actions will authorize the appropriation of \$5,950 from available General Fund salary savings in the City’s Parks and Landscape Maintenance budget to pay additional costs incurred as part of the “Skate Park at Kennedy Park,” Project No. 428-2590-XXXXX-71102.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. The City Council amends the Fiscal Year 2024-25 Operating Budget by unappropriating \$5,950 of salary savings from the City’s General Fund Parks and Landscape Maintenance Budget (101-4011-51012-00000).

SECTION 1. The City Council amends the Fiscal Year 2024-25 Capital Improvement Program (CIP) Budget by appropriating \$5,950 of General Fund (Transfer to CIP: 101-2590-89987-71102, Transfer from General Fund to Project: 428-2590-80701-71102, : Expense appropriation: 428-2590-66196-71102) to “Skate Park at Kennedy Park,” Project No. 428-2590-XXXXX-71102.

SECTION 2. The City Clerk shall attest and certify to the passage and adoption of this Resolution, and it shall become effective immediately upon its approval.
