## RESOLUTION NO. 2025-126

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, DECLARING ITS INTENT TO EXTEND THE CURRENT NON-EXCLUSIVE TOWING FRANCHISES FOR CITY-INITIATED TOWS FOR A THREE-YEAR TERM AND SETTING THE DATE FOR THE PUBLIC HEARING TO INTRODUCE AN ORDINANCE APPROVING THE EXTENSIONS OF THE CURRENT NON-EXCLUSIVE FRANCHISES

WHEREAS, Article XIII of the Pomona City Charter sets for the procedure for awarding franchises;

WHEREAS, Chapter 58, Article VIII of the Pomona City Code ("PCC") sets forth the eligibility criteria and procedures specific to awarding and extending non-exclusive towing franchises for City-initiated tows;

WHEREAS, there are currently four non-exclusive towing franchises for City initiated tows, which were awarded by City Council Ordinance No. 4325 (adopted on December 19, 2022), and expire on January 18, 2026;

WHEREAS, in accordance with PCC section 58-678, the franchises may be extended pursuant to terms set forth in the franchise agreements;

WHEREAS, Sanders Towing, Inc., S & J Towing Service, Inc., Carpe Carma, L.L.C. dba Pomona Valley Towing, Inc., and Al & Son's Towing, Inc. have each submitted written requests to extend their franchise agreements for three years;

WHEREAS, in consideration of extending four Non-Exclusive Franchises for City-Initiated Tows for a term of three years, the City Council intends to hold a public hearing on November 17, 2025 at 7:00 p.m. in the City Council Chambers located at 505 S. Garey Avenue, Pomona, California on the introduction of an ordinance to extend the current non-exclusive towing franchise agreements with Sanders Towing, Inc., S & J Towing Service, Inc., Carpe Carma, L.L.C. dba Pomona Valley Towing, Inc., and Al & Son's Towing, Inc.;

**WHEREAS**, the notice of the public hearing will be published in the Inland Valley Daily Bulletin and on the City's website at least two weeks prior to the hearing date.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona as follows:

<u>SECTION 1.</u> That the City Council hereby declares its intent to extend four non-exclusive towing franchises for City-initiated tows with Sanders Towing, Inc., S & J Towing Service, Inc., Carpe Carma, L.L.C. dba Pomona Valley Towing, Inc., and Al & Son's Towing, Inc. for a term of three years.

SECTION 2. That a duly noticed public hearing on the matter of extending the nonexclusive towing franchise agreement will be held on November 17, 2025, at 7:00 p.m. in the City Council Chambers located at 505 S. Garey Avenue, Pomona, California.

**SECTION 3.** That after receiving public comment and testimony at the public hearing. the City Council intends to introduce an ordinance extending the non-exclusive towing franchise agreements for City-initiated tows for three years,

**SECTION 4.** The City Clerk shall attest and certify to the approval and passage of this resolution, and it shall be effective immediately upon its adoption.
