SUBJECT: AWARD OF AGREEMENT TO STANTEC CONSULTING SERVICES,

INC., FOR PROFESSIONAL SERVICES FOR ENGINEERING AND ENVIRONMENTAL MITIGATION SERVICES FOR "PEDLEY

SPREADING GROUNDS - POND ENHANCEMENTS" PROJECT

RECOMMENDATION:

It is recommended that the City Council take the following actions:

- 1) Approve awarding an agreement with Stantec Consulting Services, Inc., for professional services for Engineering and Environmental Mitigation Services for "Pedley Spreading Grounds Pond Enhancements", Project No. 428-2590-XXXXX-81058 in the amount of \$545,964; and
- 2) Authorize the City Manager to execute an agreement with Stantec Consulting Services, Inc., on behalf of the City and any subsequent documents or amendments, Attachment 1.

EXECUTIVE SUMMARY:

The recommended actions will award an agreement to Stantec Consulting Services in the amount of \$545,964. The award of the agreement will support the construction of the Pedley Spreading Grounds Pond Enhancements project by providing technical engineering review of construction documentation, observations of key construction milestones, and by ensuring compliance with the project Mitigation Monitoring and Reporting Program (MMRP) per California Environmental Quality Act (CEQA) requirements through oversight, training, and on-site monitoring.

PUBLIC NOTICING REQUIREMENTS:

In accordance with Section 2-993.1(4) (a) of the City's Purchasing Ordinance, a Public Notice inviting bids, Invitation For Bids, (IFB) # 2025-1019 was posted on the City's electronic bidding platform, PlanetBids, on April 2, 2025.

PREVIOUS RELATED ACTION:

On January 4, 2021, City Council approved a Transfer Agreement from the Los Angeles Flood Control District (LACFCD) Safe Clean Water Program (SCWP) fund under Measure W in the total amount of \$2,825,900.

On October 4, 2021, City Council approved award of a design contract to Stantec Consulting Services, Inc., for the design of the project.

On May 15, 2023, City Council approved the Mitigated Negative Declaration and the Mitigation Monitoring and Reporting Program (MMRP) in compliance with the California Environmental Quality Act (CEQA) for the "Pedley Spreading Grounds Pond Enhancements Project".

ENVIRONMENTAL IMPACT:

Construction of this project is subject to the terms of the MMRP per CEQA compliance requirements. Award of this contract will allow Stantec to conduct necessary environmental trainings, surveys, monitoring, documentation, mitigation, and reporting requirements to meet the terms of the MMRP.

Under separate agreement, the City will contract with Kizh Nation Resources Management to perform Native American monitoring services and will coordinate closely with the Yuhaaviatam of San Manuel Nation per the terms of the MMRP.

The City will allocate funds to participate in a mitigation banking program for the off-site habitat restoration of native riparian vegetation permanently impacted by construction, where such impacts cannot be avoided.

DISCUSSION:

The Pedley Spreading Grounds (PSG) is an existing groundwater recharge facility consisting of three basins that currently receive local stormwater runoff and process water from the adjacent Pedley Filtration Plant. The proposed project, funded in part by the Safe Clean Water Regional Program, will enhance PSG's capacity to capture, treat, and infiltrate local urban runoff, increasing water supply through groundwater infiltration.

Engineering services during construction will provide technical oversight and review to ensure compliance with contract documents and design intent. Services include responding to RFIs, reviewing contractor submittals, assisting with change orders, preparing conformed drawings, and conducting special construction observations at key milestones.

Environmental mitigation services will ensure compliance with the City-adopted Mitigation Monitoring and Reporting Program (MMRP) and applicable state and federal regulations throughout all phases of the Project. Services include environmental awareness training, biological and paleontological monitoring, habitat restoration, mitigation plan development and review, and preparation of a post-construction compliance and operations and maintenance plan to document and sustain adherence to mitigation measures and treatment effectiveness.

In accordance with Section 2-993(4) of the City's Purchasing Ordinance, an IFB No. 2025-1019 – "Engineering and Environmental Mitigation Services for Pedley Spreading Grounds Pond Enhancements CIP 81058," was issued on the City's electronic bidding platform on April 2, 2025. The solicitation notified 57 prospective bidders, of which one (1) proposals were received, bid results shown in Table 2.
