## 3. Internal Investigation Review; Inspector General Report

Stephen Connolly from the OIR Group gave an overview of their report on the police department's investigation and the recommendations the OIR Group made to the Chief.

Commissioners asked questions regarding the report. Mr. Connolly and Captain Rodriguez answered questions.

## 4. Monthly Report(s) from the Police Department.

Chair Russell, Commissioner Ratcliffe, and Commissioner Gibani asked questions about the report.

Captain Rodriguez answered their questions.

Chair Russell commented on the open investigations list and asked how the commission could receive more information about these in order to discuss whether the commission could pull these for review by the inspector general. Ms. Talley advised there is a confidentiality issue and she would have an internal conversation with the Chief and

Inspector general to see if more information could be added to the report.

Chair Russell requested the report show the statistics from the same month last year (i.e. March 2024 to March 2025) instead of December for year end statistics. Commissioners expressed support for that change and Captain Rodriguez advised that will be changed for next month's report.

### **INSPECTOR GENERAL COMMUNICATION**

The Inspector General indicated that their discussion item report was the only communication they had for this meeting.

### **STAFF COMMUNICATION**

Captain Rodriguez reported on two female police officers that recently received awards.

Corporal Jacqueline Smith received the US Attorney's Office Law Enforcement Award for her contributions on a complex human trafficking case to led to a federal life sentence for a trafficker.

K9 Officer Yasmin Rodriguez received the 2025 Ontario Elks Officer of the Year.

### **COMMISSIONER COMMUNICATION**

Chair Russell advised she had met with Lt. Brown regarding the Community Awareness event and would be meeting with him again. She noted the budget challenges the City is facing and is hoping to utilize existing police department programs

Commissioner Ratcliffe reported he had participated in Neighborhood Watch meetings and encouraged people there to attend commission meetings. He suggested exit interviews for the commissioners whose term has ended to improve on the experience for future commissioners. He requested a presentation from the fire department regarding arson crimes.

Chair Russell encouraged the commissioners whose term will be expiring in October to reapply.

Commission Secretary Shipman reviewed items for May's agenda.
