SUBJECT: AWARD OF PROFESSIONAL CONSULTANT SERVICES AGREEMENT

FOR THE "STREET REHABILITATION - DISTRICTS 2 AND 3," CITY PROJECT NO. 428-2590-XXXXX-67935, FEDERAL PROJECT NO. STPL-

5070(044)

#### **RECOMMENDATION:**

It is recommended that the City Council take the following action:

Award a Professional Consultant Services Agreement for "Street Rehabilitation - Districts 2 and 3," City Project No. 428-2590-XXXXX-67935, Federal Project No. STPL-5070(044) to RKA Consulting Group for Design and Construction Management services in the amount of \$200,000.

#### **EXECUTIVE SUMMARY:**

This action will result in awarding a Professional Services Agreement to RKA Consulting Group in the amount of \$200,000.00, for the "Street Rehabilitation - Districts 2 and 3," City Project No. 428-2590-XXXXX-67935, Federal Project No. STPL-5070(044) design, inspection, and construction management.

### PREVIOUS RELATED ACTION:

On June 7, 2021, the City Council approved the FY 2021-22 CIP Budget with Resolution 2021-71, which included the new CIP Project, "Street Rehabilitation - Districts 2 and 3," Project No. 428-2590-XXXXX-67935, appropriating \$200,000 each of Measure R, Measure M and Prop C funds to the project.

On June 6, 2022, the City Council approved the FY 2022-23 CIP Budget with Resolution 2022-94, which included an appropriation of \$200,000 of Measure M Funds to "Street Rehabilitation - Districts 2 and 3," Project No. 428-2590-XXXXXX-67935.

On June 5, 2023, the City Council approved the FY 2023-24 CIP Budget with Resolution 2023-94, which included an appropriation of \$400,000 of Measure M Funds to, "Street Rehabilitation - Districts 2 and 3," Project No. 428-2590-XXXXX-67935.

On December 4, 2023, the City Council unappropriated \$200,000 of Measure R funds from the project.

On April 15, 2024, the City Council Unappropriated \$200,000 of Measure M funds from the project.

On June 3, 2024, the City Council approved the FY 2024-25 CIP Budget with Resolution 2024-85, which included an appropriation of \$200,000 of Measure R Funds to "Street Rehabilitation - Districts 2 and 3," Project No. 428-2590-XXXXX-67935.

#### **DISCUSSION:**

A Request for Proposals (RFP# 2024-59) for the professional consultant services was posted to PlanetBids on October 3, 2024; eleven (11) vendors were notified with seven (7) prospective bidders, and two (2) complete bids were received. With RKA being selected as the lowest and responsible bidder.

The consultant services include the design phase beginning February 2025 to June 2025, as well as construction management/inspection during the construction phase at a later time.
