# Residential Program Participants Schedule

Welcome to FlexWise, Pomona's peak load reduction demand response program ("Program")

#### **Program Applicability:**

This Program schedule is optional for Pomona residential customers on rates TOU-D-PRIME, TOU-D-4, and TOU-D-5 who have an interval meter, or an Edison SmartConnect meter installed and program ready.

#### General terms and conditions:

Participants must meet the following eligibility requirements to participate in the Program:

- 1. You must be a Pomona Choice Energy ("Pomona") electricity account holder.
- 2. You must be on a residential rate for the duration of the Program.
- 3. Customers on Medical Baseline discount are not eligible for the Program.
- 4. You must be at least eighteen (18) years old.
- 5. The service account must be serviced by a Southern California Edison (SCE)-approved smart meter ("Smart Meter").
- 6. Your account may not be enrolled in SCE's Summer Discount Program (SDP), other SCE Demand Response (DR) programs, or any other third-party DR programs. Customers enrolled in any of these programs must disenroll prior to enrolling in the Pomona program.
- 7. In all cases, you must have an online SCE account, which will be able to give Pomona access to your meter data pursuant to SCE Rule 24. If you do not have an SCE login, you will be prompted to create one before you can sign up for the Program.
- 8. You must agree to and comply with these Terms and Conditions.

#### Territory:

Program available to Pomona customers served within the entire territory served.

#### **Special Conditions:**

FlexWise is an event-based pricing option which provides bill credits during summer Non-Event Credit Periods and incremental bill charges for load service by Pomona during FlexWise Event Charge Periods. No FlexWise credits will be provided for exported generation, i.e., energy produced and exported by the customer's generating facility, during FlexWise Non-Event Periods.

Applicable rate periods are defined as follows:

a. FlexWise Event Periods:

FlexWise Event Energy Charge Periods: 4:00 p.m. to 9:00 p.m. Summer and Winter days

during a FlexWise Event only.

FlexWise Non-event Demand Credit Periods: 4:00 p.m. to 9:00 p.m. Summer Season when a

FlexWise Event is NOT occurring.

b. FlexWise Events: Pomona may, at its discretion, call a FlexWise Event any day. FlexWise Events will be called based on any of the following criteria:

- 1) California Independent System Operator (CAISO) Alert or Warning Notice,
- 2) Forecasts of SCE system emergencies may be declared at the generation, transmission, or distribution level
- 3) Forecasts of extreme or unusual temperature conditions impacting system demand
- 4) Day-ahead load and/or price forecasts
- c. Number of FlexWise Events: There will be a minimum of 12 FlexWise events and a maximum of 15 FlexWise Events per calendar year.
- d. Notification of FlexWise Event: Pomona will notify customers of a FlexWise Event via Pomona's notification system. Customers are responsible for providing Pomona with contact information consisting of a telephone number, electronic mail address, and/or SMS text number for notification of Events. Customers are responsible for updating customer contact information as necessary. Pomona will begin to notify customers no later than 3:00 p.m. the day before a FlexWise Event. Customers are responsible for all charges incurred during a FlexWise Event, even if notice is not received. Customers who fail to provide the necessary contact information prior to FlexWise Events are responsible for all charges incurred during FlexWise Events.
- e. Participation in other Programs: Only Pomona customers shall be served under schedule FlexWise. Medical Baseline customers and Customers served under DM, DMS-1, DMS-2, TOU-EV-1, and S, are not eligible for service under this Schedule. Customers served under this schedule are not eligible to dually enroll in any demand response program offered by Pomona or any third-party administered demand response program.

Holidays are New Year's Day (January 1), Presidents' Day (third Monday in February), Memorial Day (last Monday in May), Independence Day (July 4), Labor Day (first Monday in September), Veterans Day (November 11), Thanksgiving Day (fourth Thursday in November), and Christmas Day (December 25).

When any holiday listed above falls on Sunday, the following Monday will be recognized as a holiday. No change will be made for holidays falling on Saturday.

The Summer Season shall commence at 12:00 a.m. on June 1 and continue until 12:00 a.m. on October 1 of each year. The Winter Season shall commence at 12:00 a.m. on October 1 of each year and continue until 12:00 a.m. on June 1 of the following year.
