Public Speaker Debra Mendez, Pomona Economic Opportunity Center, expressed dissatisfaction with the ordinance and requested a tenant anti-harassment ordinance be added.

Public Speaker Miranda Sheffield expressed frustration with the ordinance.

Public Comment on Agenda: 2nd Reading of Rent Control Ordinance

Nov. 17, 2025

Dear Pomona City Council,

Thank you for making the updates to the rent control ordinance. Please ensure some more clarity on the following:

- 1. What it means to be 'living' in the unit and who a 'tenant' is. The way the ordinance is written now doesn't clarify that, and that is very important as it's a matter of thousands of dollars in potential relocation subsidies that the landlord would have to pay. Namely, what is the difference between a 'qualified tenant' and 'all other tenants who have lived in the unit'. Recommendation: make it crystal clear and avoid lawsuits, please state that they must be listed on the lease. Tenants sometimes have longer-term guests and it is very hard for landlords to determine who "actually" lives there. If you don't clarify this, it will be a matter of she says-he says.
- 2. For the relocation assistance/ subsidies, the State mandates one month rent. That seems minimal, but then your \$12,998 price tag per 'qualified tenant' and \$6,164 for others is exorbitant. I appreciate that smaller landlords have to pay less, but only by \$1000 or so. This will break the bank for small landlords and they will not bother doing major renovations as needed for the unit.
- 3. It is unclear how it will be proven if the tenant receives relocation subsidies from another agency. Also, what if the tenant receives \$12,997 from another agency, a dollar less than your currently-mandated \$12,998. From the way I read the document, this would NOT exempt the tenant, and the landlord would still have to pay City of Pomona's amount of \$12,998. It should be a progressive amount or the difference of the two.

Thank you, and I hope you can clarify this before voting tonight.
