Frank Guzman, Pomona Valley Pride Center

Guzman shared regarding the Artwork unveiling of an AIPP funded stained-glass art project by Juan Martin del Campo Jr. from the 2022 Call for Art. The unveiling will take place on Saturday, September 27, 2025, from 5PM – 6:30PM at the location of the artwork and Pride Center, 235 W. Mission Blvd, Pomona, CA 91723.

1. 2022 Call for Art

There is now only one remaining project from this Call. There will be update regarding this final project by Artist Gary V. Lett at the next Commission meeting.

1. Commission Absences per Bylaws

3. Action Plan – Discussion of next steps as we close out the current Action Plan 2020-2025 (Continued).

Program Manager Ayala presented on the internal meetings that staff has conducted with other Departments that are impacted by Art and spoke about scheduling external meetings with the community. The collected input from the two internal meetings with Public Works and Community Services was shared via a word cloud that would launch the discussion.

Commissioner Swodeck recommended organizing the action plan in terms of a color code (red, yellow, green, orange) to signify levels ease.

Chairperson Ornelas added kinetic sculptures to be mentioned as possible future art projects.

Commissioner Swodeck mentioned theater as an art form to support in the City and referenced the Ganesha Bandshell lights as a way the City has supported the possibility of more performance based art. As well as, building a policy for conservation plans of public artwork. This can include ensuring that older murals are being restored with new protection coatings of anti-graffiti.

Chairperson Ornelas brought up the possibility of roundabout sculptures and building a program with students to learn about sculpture fabrication.

Commissioner Tessier noted wanting more sculptures and functional art throughout the parks and roundabouts due to having too many murals.

Vice-Chair Soiseth noted shade structures as a possibility and referenced Claremont bus stops.

Commissioner Swodeck talked about over the years there have been issues and desired goals to establish art at the bus stops.

Deputy Director Khan mentioned Foothill transit being more reliant on the City to do things at the bus stops and elaborated on the shade structures at bus stops in Claremont running the risk of not being as functional as believed due to shade analysis.

Vice-Chair Soiseth added how eye catching the shade structures are.

Deputy Director Khan mentioned utility box wraps.

Vice-Chair Soiseth added that there should be an opportunity for neighborhoods to shine

their own identity/qualities in the large parts of the City.

Deputy Director Khan brought up the roundabouts, specifically the one on Park and Ninth Street, that could host a sculpture that was designed with input from the surrounding community.

Commissioner Esparza brought up establishing an art compound, similar to the Leimert Park Cultural Hub or the Hollywood Arts Collective, that support artists. Also, adding in programming that teaches artists how to be their own business.

Chairperson Ornelas mentioned the Venice Beach diversion wall for graffiti/tagging.

Deputy Director Khan mentioned the possibility of doing micro-galleries.

Vice-Chair Soiseth mentioned doing a micro-gallery outside the library.

Commissioner Swodeck mentioned hidden micro-galleries in alleys and shops, possibly adding larger spaces like storge containers, and referenced Third St. Gallery as a point of context.

Commissioner Esparza brought up gallery rentals as well.

Deputy Director Khan mentioned San Diego's Barrio Logan as a reference to initiatives that a City has funded to establish.

Commissioner Swodeck brought up how Cultural Arts Commission used to be for all Arts in the City but has since switched to focus primarily on the Art in Public Places program.

Chairperson Ornelas brought up activating community centers through working with community partners to establish an Art in the Parks program.

Commissioner Swodeck mentioned that art can create a safer space/environment.

Commissioner Esparza mentioned the missing panels in VPD lots by Merendero.

Deputy Director Khan ended the items discussion.
