PUBLIC HEARING ITEMS

1. Development Plan Review (DPR-022671-2023) – 1423 S. Gibbs Street

Associate Planner Molina presented the item.

- 1. 8-unit housing development project on 0.49 acres (four separate, two-story buildings)
- 2. Inclusionary housing and SB330 applicable
- 3. Project consist of a shorter distance of the fire lane allowing for better access to all amenities.

- 4. Project has sufficient pedestrian circulation that separates from vehicle and fire access lanes.
- 5. All the walkways fully connect to the entire of the lot.
- 6. CEQA Exemption, Class 32
- 7. Staff received two public comments, one letter opposing the project

- 1. What is the square footage of each unit
- 2. Existing structures on site older than 50 years where they approved by HPC
- 3. Are any of the parking spaces ADA required or assigned to units
- 4. She asked how they will manage the parking spaces
- 5. Is it necessary to have two trash enclosures to possibly provide an extra parking space
- 6. Does the project consist of moderate/low-income housing
- 7. Are the maintenance requirements included in the resolution as conditions

A motion by Zoning Administrator Donavanik to approve Development Plan Review (DPR-022671-2023) with condition (1) to explore the feasibility of eliminating the second trash enclosure adjacent to the parking stalls, and relocate the bicycle parking, to add two additional parking spaces.
