Office of Violence Prevention established in 2022, due to data received stating that during a ten year span, there was one shooting per week. 90% of the gun shootings is driven by 2-3% population, by males in their 30s

GOALS OF PROGRAM

I.

Reduce participation in homicides, non-fatal shootings and aggravated assaults through the Peacemaker Fellowship Program (model from Advance Peace Program) More intervention focused. Change advocates (former gang members helping to identify those who the program to target); 18 mos of case management; Program rolled out in February and currently have 40 participants enrolled; experiencing 18% reduction in shootings, 55% reduction in gun homicides;

II.

Increase social cohesion in areas affected; increase sense of safety; resource fairs, pop-up events and awareness campaigns

Strengthen police/community relations; Pomona PD Procedural Justice Training, giving a voice, respect to potential participants

Grant funds awarded to OVP was \$5.1 mil for over a 3 1/2 year period; OVP will be receiving an additional \$8 mil for a Diversion Program, also over a 3 1/2 year period.

Movement and the push is to make this program institutionalized in the city charter.

Stephanie Zepeda, Founder of Project Resilience, helps women who are being exploited in sex trafficking

Project Resilience receives grant funds but not enough to cover all expenses.

Hours of Operation Monday - Friday 9:00 am - 5:30 pm (Accepts clothing donations)

Services provided are case management, street outreach, substance abuse classes, client advocacy, and community awareness.
