PUBLICATION OF ENGINEER'S REPORT AND ADOPTION OF A RESOLUTION APPROVING THE ENGINEER'S REPORT FOR CONSOLIDATED CITYWIDE STREET LIGHTING AND LANDSCAPING MAINTENANCE DISTRICT ZONES A THROUGH I- FISCAL YEAR 2025-26 AND DECLARING THE CITY'S INTENTION TO PROVIDE ANNEXATION OF ADDITIONAL TERRITORY, COLLECT ASSESSMENTS, AND SET A PUBLIC HEARING FOR JULY 21, 2025.

NOTICE IS HEREBY GIVEN THAT A PUBLIC HEARING ON THESE MATTERS WILL BE HELD MONDAY, THE 21ST DAY OF JULY 2025, AT THE HOUR OF 7:00 P.M., IN THE CITY COUNCIL CHAMBERS LOCATED AT 505 SOUTH GAREY AVENUE, POMONA, CALIFORNIA. THE TIME AND PLACE ARE SET BY THIS CITY COUNCIL FOR THE HEARING OF PROTESTS OR OBJECTIONS IN REFERENCE TO THE ANNEXATION OF ADDITIONAL TERRITORY AND ANNUAL LEVY OF ASSESSMENTS, TO THE EXTENT OF THE MAINTENANCE, AND ANY OTHER MATTERS CONTAINED IN THIS RESOLUTION BY THOSE PROPERTY OWNERS AFFECTED HEREBY. ANY PERSONS WHO WISH TO OBJECT TO THE PROCEEDINGS SHOULD FILE A WRITTEN PROTEST WITH THE CITY CLERK PRIOR TO THE TIME SET AND SCHEDULED FOR SAID PUBLIC HEARING.

THIS PUBLIC NOTICE IS PURSUANT TO THE TERMS AND PROVISIONS OF THE LANDSCAPING AND LIGHTING ACT OF 1972, BEING DIVISION 15, PART 2 OF THE STREETS AND HIGHWAYS CODE OF THE STATE OF CALIFORNIA.

AT THE PUBLIC HEARING ON THE DATE, TIME, AND PLACE STATED ABOVE, ANY INTERESTED PERSON MAY APPEAR AND BE HEARD REGARDING THE APPROVAL OF THE ENGINEER'S REPORT FOR CONSOLIDATED CITYWIDE STREET LIGHTING AND LANDSCAPING MAINTENANCE DISTRICT ZONES A THROUGH I- FISCAL YEAR 2025-26, AND DECLARING THE CITY'S INTENTION TO PROVIDE ANNEXATION OF ADDITIONAL TERRITORY, COLLECT ASSESSMENTS.

**RESOLUTION NO. 2025-66**

**A RESOLUTION OF THE CITY COUNCIL OF POMONA, CALIFORNIA, TO ANNEX NEW TERRITORY AND LEVY FISCAL YEAR 2025-26 ASSESSMENTS FOR THE CONSOLIDATED CITYWIDE STREET LIGHTING AND LANDSCAPING MAINTENANCE DISTRICT AND TO SET JULY 21, 2025 AS THE DATE FOR THE PUBLIC HEARING ON THE MATTER**

**WHEREAS**, the City of Pomona established its first Street Lighting and Landscape Assessment District over 35 years ago, followed by several additional districts before establishing one Consolidated Citywide Street Lighting and Landscaping Maintenance District in 1990; and

**WHEREAS**, the current Consolidated Citywide Street Lighting and Landscaping Maintenance District is comprised of nine (9) Benefit Zones for the benefit of maintaining specific landscaping and street lighting improvements; and

**WHEREAS**, on March 17, 2025, the City Council of the City of Pomona, pursuant to the terms and provisions of Division 15, Part 2 of the Streets and Highways Code of the State of California, adopted Resolution 2025-29 authorizing David Taussig and Associates (DTA) as the Engineer of Record and ordering the preparation of an Engineer's Report for the Annual Levy of Fiscal Year 2025-26 Assessments, consisting of plans and specifications, an estimate of the cost, a diagram of the area proposed to be annexed, a diagram of the District, and assessments relating to what is now known and designated as:

**CITY OF POMONA CONSOLIDATED CITYWIDE STREET LIGHTING AND LANDSCAPING MAINTENANCE DISTRICT**

**WHEREAS**, the City Council desires to annex 125 new parcels and levy Fiscal Year 2025-26 assessments for the existing Consolidated Citywide Street Lighting and Landscaping Maintenance District (District), in accordance with the terms and provisions of the Landscaping and Lighting Act of 1972, being Division 15, Part 2 of the Streets and Highways Code of the State of California; and

**WHEREAS**, the City Council has carefully examined and reviewed the Preliminary Engineer's Report, as presented, which is on file with the Office of the City Clerk, and is satisfied with all of the items and documents set forth therein, and is satisfied that the assessments have been distributed in accordance with the proportional benefits received and maintenance to be performed throughout the District; and

**WHEREAS**, satisfied with the Assessment Diagram and assessment proportionality, the City Council has approved the "Engineer's Report" as required by law, and desires to proceed with adopting a Resolution of its Intention to annex additional parcels and levy Fiscal Year 2025-26 assessments and set the date, time and place to conduct the public hearing on this matter; and

**WHEREAS**, California Government Code Section 22625 requires a public hearing regarding the proposed levy of assessments be held at a regular meeting of the legislative body.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona as follows:

**SECTION 1.** That the above recitals are all true and correct.

**SECTION 2. Intent** - That it is the intention of the City Council to undertake proceedings for the annexation of additional parcels and the annual levy and collection of Fiscal Year 2025-26 assessments for the City of Pomona Street Lighting and Landscaping District (District). There is no increase to assessments from the previous fiscal year.

**SECTION 3. Purpose** - That the revenue derived from the District assessments is solely for the purpose of maintaining certain landscaping and street lighting improvements throughout the District.

**SECTION 4. District Designation** - That there are 125 new parcels to be annexed into the District, which are listed in the Engineer's Report. The benefit zones within the District are generally comprised as follows:

- Landscaping Only - Zone A (Phillips Ranch); and
- Lighting and Landscaping - Zone B (Phillips Ranch), Zone D (Garey Avenue – State Route 71/Lexington), Zone E (Garey Avenue – Auto Center), Zone F (Garey Avenue – Lexington to Ninth), and Zone H (University Corporate Center)
- Street Light Maintenance – Zones C (District-wide) and I (Emerald Court)

The details of the parcels to be annexed and the parcels within the different benefit zones of the District are contained in the Assessment Diagram of the Engineer's Report on file and are available for review in the Office of the City Clerk.

**SECTION 5. Notice of Public Hearing** – That the date, time and location for the Public Hearing on annexation of new parcels and the levy and collection of Fiscal Year 2025-26 assessments for the District shall be as follows:

PROPERTY OWNERS AFFECTED BY THE ANNEXATION OF NEW PARCELS AND/OR THE ANNUAL LEVY OF ASSESSMENTS FOR MAINTENANCE OR OTHER MATTERS CONTAINED IN THIS RESOLUTION SHOULD FILE A WRITTEN PROTEST WITH THE CITY CLERK PRIOR TO THE TIME SCHEDULED FOR THE PUBLIC HEARING.

**SECTION 6.** The City Clerk is directed to publish this Resolution of Intent to annex additional parcels and levy and collect the Fiscal Year 2025-26 assessments and setting the time and place for the public hearing on the matter, pursuant to Section 22552 and 22553 of California Streets and Highways Code. Said Resolution shall be posted on the Noticing Bulletin Board and published in the Inland Valley Daily Bulletin no later than ten days prior to the date set for the Public Hearing.
