4) FY 2025-26 General Fund Preliminary Budget Preview

The FY 2025-26 General Fund Preliminary Budget Preview was presented by Finance Director, Andrew Mowbray.

MOTION BY COMMITTEE MEMBER PINEDA, SECOND BY COMMITTEE MEMBER SANCHEZ, CARRIED 6-0 (COMMITTEE MEMBER MORALES ABSENT), to receive and file the FY 2025-26 General Fund Preliminary Budget Preview.

There was no public comment on this item.

#### **COMMITTEE MEMBER COMMUNICATION**

Committee Chair Chu inquired if the Committee should make a presentation at the Budget Study Session.

Committee Member Jones stated that the committee should always make a statement at the Community Budget meetings so that the committee can be heard.

Committee Member Sanchez had gone to a community budget meeting and found it very informative.

Committee Chair Chu stated that the committee supports the new community budget forum process that encourages citizens' engagement.

The Committee agreed on their focus for the Budget Study Session: Public Safety, the Youth Program, Economic Development, and Housing.

Director Mowbray related that a statement will be drafted including the recommendations from the Committee. Only 3 members of the committee should attend the Budget Study Session due to the Brown Act.

Committee Member Casillas Sanchez requested to include that the committee would like to ensure that essential services are maintained.

Revenue Manager Perez will send a draft of the recommendations to the Committee and the Committee will respond, individually, to Chair Chu regarding their approval. Chair Chu will then read the recommendations from the committee at the May 12, 2025 Budget Study Session.
