A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING THE FISCAL YEAR 2024-25 OPERATING BUDGET BY APPROPRIATING \$1,645,780 FROM GENERAL FUND RESERVES AND TRANSFERING THE SAME AMOUNT TO THE POMONA FUND FOR CHILDREN AND YOUTH
A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING THE FISCAL YEAR 2024-25 OPERATING BUDGET BY APPROPRIATING \$1,645,780 FROM GENERAL FUND RESERVES AND TRANSFERRING THE SAME AMOUNT TO THE POMONA SPECIAL REVENUE FUND FOR CHILDREN AND YOUTH

WHEREAS, the City routinely adjusts fiscal year appropriations and revenue estimates throughout the fiscal year.

WHEREAS, the City Council adopted the operating and capital improvement program budgets of the City of Pomona for fiscal year 2024-25 on June 3, 2024 and all authorized staffing levels for departments or major organizational units within all operating funds and capital improvements programs were approved.

WHEREAS, the City Council approved amendments to the fiscal year 2024-25 General Fund Operating budget on July 15, 2024, September 9, 2024, October 7, 2024, October 21, 2024 and November 18, 2024.

WHEREAS, the City Council, on February 26, 2024 received and file the Impact Analysis Report on the possible effects of the proposed “Pomona Kids First” initiative petition to amend the Pomona City Charter, and based upon the Impact Analysis Report, voted to submit the Measure to the voters at the “next regular municipal election” occurring at least 88 days later. Under Elections Code section 348, a “[R]egular election is an election, the specific time for the holding of which is prescribed by law.” The next being the City’s upcoming General Municipal Election on November 5, 2024.

WHEREAS, the City Council on December 9, 2024 received a resolution reciting the facts of the General Municipal election held November 5, 2024, declaring the result and such other matters as provided by law. Measure Y is one of the actions that was approved by the voters.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona, California, as follows:

SECTION 1. That the City Council amends the Fiscal Year 2024-2025 City operating budget by appropriating \$1,645,780 from General Fund Reserves (101-9999-89992-00000)) and then transferring \$1,645,780 to the Pomona Special Revenue Fund for Children and Youth (148-1501-80701-00000)).

SECTION 2. The City Clerk shall certify to the passage and adoption of this resolution, and it shall thereupon be in full force and effect.
