A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA AMENDING THE FY 2023-24 CAPITAL IMPROVEMENT PROGRAM (CIP) BUDGET BY UNAPPROPRIATING \$20,000 OF MEASURE R FUNDS FROM "STREET PRESERVATION – LOCAL (FY 21-22)," PROJECT NO. 428-2590-XXXXX-68572 AND \$600,000 OF SB-1/RMRA FUNDS FROM "STREET PRESERVATION – LOCAL (FY 22-23)," PROJECT NO. 428-2590-XXXXX-68582 AND APPROPRIATING THESE FUNDS TO "STREET PRESERVATION – LOCAL (FY 23-24)," PROJECT NO. 428-2590-XXXXX-68592; AND APPROPRIATING \$144,000 OF AVAILABLE DISTRICT 4 AMERICAN RESCUE PLAN (ARP) FUNDS TO "STREET IMPROVEMENTS – CITYWIDE (CDBG) (FY 22-23 TO FY 24-25)," PROJECT NO. 428-2590-XXXXX-71065

WHEREAS, the "Street Preservation – Local (FY 23-24)," Project No. 428-2590-XXXXX-68592 and "Street Improvement – Citywide (CDBG) (FY 22-23 to FY 24-25)," Project No. 428-2590-XXXXX-71065 requires additional funding for construction improvements; and

WHEREAS, the City Council desires to amend the FY 2023-24 CIP Budget by appropriating \$144,000 of District 4 American Rescue Plan (ARP) funding to "Street Improvements – Citywide (CDBG) (FY 22-23 to FY 24-25)," Project No. 428-2590-XXXXX-71065, in order to complete the rehabilitation of San Francisco Avenue from San Antonio Avenue to Palomares Avenue, as funds allow.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. The City Council amends the FY 2023-24 CIP Budget by unappropriating \$20,000 of Measure R funding (128-2590-89987-68572 CR; 428-2590-80864-68572 DR; 428-2590-66196-68572) from "Street Preservation – Local (FY 21-22)," Project No. 428-2590-XXXXX-68572.

SECTION 2. The City Council amends the FY 2023-24 CIP Budget by unappropriating \$600,000 of SB-1/RMRA funding (206-2590-89987-68582 CR; 428-2590-80698-68582 DR and 428-2590-66196-68582) from "Street Preservation – Local (FY 21-22)," Project No. 428-2590-XXXXX-68582.

SECTION 3. The City Council amends the FY 2023-24 CIP Budget by appropriating \$144,000 of District 4 ARP funding (191-0204-89987-71065; 428-2590-80881-71065 and 428-2590-66196-71065) to "Street Improvement – Citywide (CDBG) (FY 22-23 to FY 24-25)," Project No. 428-2590-XXXXX-71065.

SECTION 4. The City Council amends the FY 2023-24 CIP Budget by appropriating \$20,000 of available Measure R funding (128-2590-89987-68592, 428-2590-80864-68592, 428-2590-66196-68592) and \$600,000 of available SB-1/RMRA funding (206-2590-89987-68592, 428-2590-80698-68592, 428-2590-66196-68592) to "Street Preservation - Local (FY 23-24)," Project No. 428-2590-XXXXX-68592.
