

RESOLUTION NO. 2025-134

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, TO ACCEPT FISCAL YEAR 2025-26 NUTRITION SERVICES INCENTIVE PROGRAM (NSIP) FUNDING ALLOCATION FOR ELDERLY NUTRITION PROGRAM (ENP) SERVICES GRANT FUNDS FROM LOS ANGELES COUNTY FOR SENIOR MEAL SERVICES IN THE AMOUNT OF \$35,790 AND AMEND THE FY 2025-26 OPERATING BUDGET SENIOR NUTRITION GRANT FUND BY INCREASING REVENUE ESTIMATES AND APPROPRIATIONS IN THE AMOUNT OF \$35,790

WHEREAS, the City's Elderly Nutrition Program (ENP) continues to provide free, nutritious meals to senior adults and adults with disabilities; and

WHEREAS, the County of Los Angeles County Aging and Disabilities Department (County) provided Amendment No. 1 to the ENP Older Americans Act (OAA) Title III C-1 (Nutrition Services), Nutrition Services Incentive Program (NSIP) funding in the amount of \$35,790 for FY 2025-26 in grant meal services reimbursement funding to City from the County;

WHEREAS, the FY 2025-26 Operating Budget currently includes County provided grant revenue and expenditures for the ENP.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. The City Council accepts the County of Los Angeles Nutrition Services Incentive Program (NSIP) funding allocation for ENP services for the Subaward Sum Year 1 (SSY 1) in the amount of \$35,790 for the FY 2025-26 ENP/NSIP Grant.

SECTION 2. The FY 2024-25 Operating Budget shall be amended by increasing revenue estimates (226-4190-40844-00000) in the amount of \$35,790.

SECTION 3. The FY 2024-25 Operating Budget shall be amended by appropriating funds to Sr. Citizen Nutrition Program contract services 226-4190-52351-00000 in the amount of \$35,790.

SECTION 4. The City Clerk shall attest and certify to the passage and adoption of this Resolution, and it shall become effective immediately upon its approval.
