RECOMMENDATION:

It is recommended that the City Council adopt the following resolution:

RESOLUTION NO. 2024-55 – A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, APPROVING THE ACCEPTANCE OF A DONATION OF 14 NEW TABLES AND 54 NEW CHAIRS FROM THE POMONA PUBLIC LIBRARY FOUNDATION, FOR USE IN THE LIBRARY, DONATION TOTAL \$12,088

EXECUTIVE SUMMARY:

The Pomona Public Library received a donation of 14 new tables and 50 new chairs from the Pomona Public Library Foundation. These items are for public use within the multipurpose rooms and other common areas. In accordance with Sections 37354 & 37355 of the California Government Code, the legislative body may accept or reject any gift, bequest or devise, may to, or for the City.
