PROGRAM (CIP) BUDGET BY CHANGING THE PROJECT

**DESCRIPTION OF "LIBRARY FACILITY REMODEL"** 

#### **RECOMMENDATION:**

It is recommended that the City Council adopt the following resolution:

RESOLUTION NO. 2024-97 - A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING THE FY 2023-24 CAPITAL IMPROVEMENT PROGRAM (CIP) BUDGET BY CHANGING THE PROJECT DESCRIPTION OF "LIBRARY FACILITY REMODEL" PROJECT NO. 428-2590-XXXXXX-74118

#### **EXECUTIVE SUMMARY:**

Adopting Resolution No. 2024-97 (Attachment No. 1) will amend the project description of "Library Facility Remodel," Project No. 428-2590-XXXXX-74118 (Project), as reflected in the CIP Project Details Sheet (Attachment No. 2), to provide for additional tenant improvements throughout the Library and Children's Room.

# PREVIOUS RELATED ACTION:

On May 16, 2022, the City Council adopted Resolution No. 2022-84 creating the CIP Project, "Library Facility Remodel," Project No. 428-2590-XXXXX-74118, and appropriating \$350,000 of General Funds to the Project.

# **DISCUSSION:**

Adoption of the Resolution will modify the project description by replacing the following sentence, "This project will also replace the carpet in the Children's Room and sand and paint the patio trellis" with the sentence, "This project will also include various other tenant improvements, demolition, construction, and furniture enhancements throughout the Library and Children's Room." These additional improvements, throughout the Library and Children's Room, will be provided as funds allow. This project previously funded and provided improvements to the Library basement to reconfigure the space to accommodate Community Service staff members who oversee and administratively support youth programming. Separately, the Library will also be undergoing a more extensive renovation as part of a CIP project, "Pomona Library Facility Improvements," Project No. 428-2590-XXXXXX-74120.
