SUBJECT: DISCUSS THE ESTABLISHMENT OF A COMPASSIONATE FUND TO

ASSIST FAMILIES IMPACTED BY FEDERAL IMMIGRATION

ACTIVITIES

RECOMMENDATION:

It is recommended that the City Council take the following actions:

- 1) Discuss establishment and City funding for a *Compassionate Fund* to assist families impacted by Federal immigration enforcement activities; and,
- 2) Direct staff to bring back an appropriation and/or a contribution from respective City Councilmembers' discretionary Fiscal Year (FY) 2025-26 General Fund Budgets for future Council action to seed and support the establishment of a Compassionate Fund; and.
- 3) Direct staff to identify an organization to administer the Compassionate Fund and related activities.

EXECUTIVE SUMMARY:

The City Council has consistently expressed and demonstrated its support for Pomona's diverse population, including the immigrant community. In light of recent Federal activities, such as immigration raids, several local cities have coordinated, established, and/or funded programs to support their respective immigrant communities. The City Council has expressed a desire to establish and provide City funding for a Compassionate Fund to assist the city's immigrant population, particularly those who feel vulnerable or have been impacted by these recent enforcement activities.

FISCAL IMPACT:

There will be no fiscal impact from this action. However, if the City Council chooses to provide City funding support for establishing the Compassionate Fund, an appropriation from General Fund Reserves and/or a contribution from respective City Councilmembers' discretionary FY 2025-26 General Fund Budgets will be proposed at a future council meeting for approval. The FY 2025-26 General Fund Budget currently reflects a projected deficit of \$5.5M.

DISCUSSION:

The City Council has consistently expressed and demonstrated its support for Pomona's diverse population, including the immigrant community. In light of recent Federal activities, the Mayor and City Council have directed staff to place an item on the agenda to discuss establishing a Compassionate Fund, including consideration for financial support. This action reaffirms the City's strong commitment to upholding the dignity, well-being, and sense of belonging of all residents, especially those affected by these enforcement efforts.

Staff is aware of other cities and organizations that have established similar funds. While most of these initiatives are supported through private funding, at least one city launched its program using surplus General Fund dollars. In all cases, the cities have partnered with nonprofit organizations to help administer and distribute the financial assistance.

These funds typically provide food and essential supplies, mental and medical health services, and legal resources. Pomona's Compassionate Fund is intended to offer the same types of support, with specific eligibility criteria to be determined.

Given this information, it is recommended that the City Council discuss creating the Compassionate Fund to be administered by a qualified provider and, if the Council wishes to provide City funding, direct staff to return with a general fund appropriation for consideration.
