

RESOLUTION NO. 2025-100

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, ACCEPTING A FEDERAL ENVIRONMENTAL PROTECTION AGENCY (EPA) GRANT AND AMENDING FY 2025-26 CIP BUDGET BY INCREASING REVENUE ESTIMATES AND APPROPRIATIONS BY A TOTAL OF \$1,600,000 OF U.S. EPA GRANT FUNDING AND APPROPRIATIONS BY \$500,000 FROM WATER FUND BALANCE TO THE “WATER TREATMENT – VOLATILE ORGANIC COMPOUND TREATMENT PLANT”, PROJECT NO. 528-2590-XXXXX-95087

WHEREAS, the City Council has prescribed the authority by Charter of the City of Pomona to adopt and amend the Capital Improvement Program (CIP) budgets;

WHEREAS, the United States Environmental Protection Agency (U.S. EPA) has received congressional approved to earmark Federal funding for the City’s water Well 34 treatment plant;

WHEREAS, on June 30, 2022, the U.S. EPA Community Grants program issued a memorandum outlining planning guidance for the “FY 2022 Congressionally Directed Spending (CDS)/Community Project Funding (CPF) Grants Program for Water Projects”;

WHEREAS, on June 2, 2025, the City Council approved adoption of the FY 2025-26 CIP Budget which includes the “Water Treatment – Volatile Organic Compound Treatment Plant,” Project No. 528-2590-XXXXX-95087;

WHEREAS, the City Council desires to appropriate \$1,600,000 from the U.S. EPA Community Grants funding, on a reimbursable basis, and \$500,000 from Water Fund balance to fully fund this project.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. The City Council hereby amends the FY 2025-26 CIP Budget, by increasing revenue estimates and receiving and appropriating \$1,600,000 from the U.S. EPA Community Grants program reimbursable grant and appropriating \$500,000 from Water Fund Balance to the “Water Treatment – Volatile Organic Compound Treatment Plant”, Project No. 528-2590-XXXXX-95087 (528-2590-66196-95087, 528-2590-40889-95087; 571-2590-89951-95087, 528-2590-80702-95087).

SECTION 2. The City Clerk shall attest and certify to the passage and adoption of this Resolution, and it shall become effective immediately upon its approval.
