

RESOLUTION NO. 2025-79

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA TO AMEND THE FY 2024-25 CAPITAL IMPROVEMENT PROGRAM (CIP) BUDGET BY CHANGING THE NAME OF “GANESHA PARK BANDSHELL AND COMMUNITY CENTER UPGRADES,” PROJECT NO. 428-2590-XXXXX-71127, AN UNFUNDED PROJECT, TO “GANESHA PARK BANDSHELL UPGRADES,” PROJECT NO. 428-2590-XXXXX-71127 AND PARTIALLY FUNDING THE PROJECT BY APPROPRIATING \$300,000 OF AVAILABLE CIP PROJECT FUND RESERVES (GENERAL FUND) TO THE PROJECT

WHEREAS, the City Council desires to make renovations to the bandshell at Ganesha Park

WHEREAS, the City desires to amend the FY 2024-25 CIP Budget by changing the name of Ganesha Park Bandshell and Community Center Upgrades,” Project No. 428-2590-XXXXX-71127, a previously unfunded project, to “Ganesha Park Bandshell Upgrades,” Project No. 428-2590-XXXXX-71127 and appropriating \$300,000 of available CIP Project Fund Reserves (General Fund) to the Project.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. The City Council amends the FY 2024-25 CIP Budget by changing the name of “Ganesha Park Bandshell and Community Center Upgrades,” Project 428-2590-XXXXX-71127 to “Ganesha Park Bandshell Upgrades,” Project 428-2590-XXXXX-71127.

SECTION 2. The City Council amends the FY 2024-25 CIP Budget by appropriating \$300,000 of available CIP Project Fund Reserves (428-2590-80701-67010 DR, 428-2590-80701-71127 CR and 428-2590-66196-71127) to “Ganesha Park Bandshell Upgrades,” Project 428-2590-XXXXX-71127.

SECTION 3. The City Clerk shall attest and certify to the passage and adoption of this Resolution, and it shall become effective immediately upon its approval.
