SUBJECT:	APPROVAL OF LOT MERGER LM4-2023 FOR THE PROPERTY LOCATED AT 580 N. PARK AVENUE, POMONA, CA, ASSESSOR PARCEL NUMBER 8336-013-008, RELATED TO THE TENANT IMPROVEMENT OF A COMMERCIAL BUILDING (COUNCIL DISTRICT 1)

RECOMMENDATION:

It is recommended that the City Council take the following actions:

1) Adopt the following Resolution:

RESOLUTION NO. 2023-92 – A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, APPROVING LOT MERGER LM4-2023 FOR THE PROPERTY LOCATED AT 580 N. PARK AVENUE, ASSESSOR PARCEL NUMBER 8336-013-008; and

2) Authorize the City Engineer to sign the Lot Merger LM4-2023 on behalf of the City of Pomona.

EXECUTIVE SUMMARY:

Jack Lee, with CalLand Engineering, submitted the proposed lot merger application on behalf of 580 Park LLC, landowner of the adjoining real properties located at 580 N. Park Avenue, Assessor Parcel Number (APN) 8336-013-008. Approval of Resolution No. 2023-92 (Attachment No. 1) will consolidate two lots into one parcel, eliminate the lot lines crossing under the existing building, and facilitate the completion of the tenant improvements for the MKK Express, Inc. trucking company facilities. City Council approval of a lot merger is required if the lot merger was not previously considered by the Planning Commission as part of a development project.

FISCAL IMPACT:

No fiscal impact at this time.

ENVIRONMENTAL IMPACT:

Pursuant to the California Code of Regulations, Title 14, Guidelines for the Implementation of the California Environmental Quality Act (CEQA), Section 15061, the proposed lot merger is categorically exempt from the requirement for the preparation of environmental documents in that the activity is covered by the general rule that CEQA applies only to projects which have the potential for causing a significant effect on the environment.

DISCUSSION:

The real property addressed as 580 N. Park Avenue (APN 8336-013-008) is an approximately 0.33-acre, two-lot commercial development, consisting of Lots 10 and 11 of McComas's Subdivision of the West 7-1/4 Acres of Block 180 of the Pomona Tract, recorded in Book 13, Page 32 of Miscellaneous Records, in the Los Angeles County Recorder's Office. Having the same land use and land ownership, these two lots have been issued a single APN 8336-013-008 by the Los Angeles County Office of the Assessor. The property is located on the east side of Park Avenue, between Holt Avenue and Alvarado Street, and is developed with a 14,212-square-foot, one-level commercial building, a 14-space parking lot, and limited landscaped areas (Attachment Nos. 2 and 3). Vehicular access to the property and parking is provided via two driveway approaches on Park Avenue.

In July 2022, a permit application was submitted to the Pomona Building and Safety Division for office tenant improvements of the existing building. The facility is currently occupied by MKK Express, Inc. trucking company, following the 2022 property sale and relocation of the previous owner, Andreasen Engineering, Inc., to Upland, CA. As part of the proposed project, Cal Land Engineering, on behalf of the landowner, submitted a lot merger application to the Public Works Engineering Division to consolidate the aforementioned two lots into one parcel. The purpose of the merger is to eliminate the lot line crossing under the existing building and facilitate the completion of the proposed onsite tenant improvements.

Lot Merger LM4-2023 is submitted in accordance with Section 66499.20.3 of the California Government Code (Subdivision Map Act) and Section 29-50(b) of the 1959 Pomona City Code as currently adopted by reference under Chapter 78-1. In accordance with the Pomona City Code, lot mergers requested by the owner of contiguous parcels that have not been previously considered by the Planning Commission shall be submitted to the City Council for approval.

The proposed lot merger is in conformance with the City's General Plan and the City's Zoning Ordinance. This action will merge two adjoining lots designated by APN 8336-013-008 into one parcel, as described in EXHIBIT "A" and shown on the map depicted by EXHIBIT "B" to EXHIBIT 1 of Attachment No. 1.

The approval and adoption of the Resolution will allow the recording of the proposed lot merger and will facilitate the completion of the project in accordance with the approved development plans.
