

RESOLUTION NO. 2025-80

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING THE FY 2025-26 CIP BUDGET BY INCREASING REVENUE ESTIMATES BY \$800 AND APPROPRIATIONS BY A TOTAL OF \$34,927: \$800 FROM THE SOUTHERN CALIFORNIA GAS COMPANY RENT LEASE AND \$34,127 FROM WATER FUND FUNDING TO THE “WATER RESOURCES BUILDING” PROJECT NUMBER 575-8125-XXXXX-93135

WHEREAS, the City Council has prescribed the authority by Charter of the City of Pomona to adopt and amend the Capital Improvement Program (CIP) budgets;

WHEREAS, the Southern California Gas Company (SoCalGas) and the City have entered into a Settlement Agreement which stipulates the “rent payment” of \$800 per month while SoCalGas is actively working on the Water Yard cleanup; estimated to be in the amount of \$800; into the “Water Resources Building” project number 575-8125-XXXXX-93135; and,

WHEREAS, the City Council desires to appropriate Water Funds, in the amount of \$34,127 into the Water “Water Resources Building,” project number 575-8125-XXXXX-93135.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. The City Council hereby amends the FY 2025-26 CIP budget, by increasing revenue estimates and receiving and appropriating \$800 (575-8125-40190-93135, 575-8125-66196-93135) of SoCalGas rent payment revenue to “Water Resources Building,” Project No. 575-8125-XXXXX-93135.

SECTION 2. The City Council hereby amends the FY 2025-26 CIP budget by appropriating \$34,127 of Water fund balance to “Water Resources Building,” Project No. 575-8125-XXXXX-93135 (571-8125-89951-93135, 575-8125-80702-93135, 575-8125-66196-93135) from Water fund balance.

SECTION 3. The City Clerk shall attest and certify to the passage and adoption of this Resolution, and it shall become effective immediately upon its approval.
