*Per City Charter, Article VIII, Sec. 801(b) Unless otherwise specified in this Charter or by ordinance, appointive boards and commissions shall have the same number of members as there are members of the Council and shall be appointed one-to-one by the Mayor and each Councilmember within sixty (60) days of their assuming elective office. The initial term of board members and commissioners shall generally be for four (4) years. Board members and commissioners may continue to serve until their successors are appointed or until removed by a majority vote of the Council. Each board or commission shall request replacement of a member when a majority of the members determine that such replacement is necessary for the proper functioning of the board or commission.
