

**RESOLUTION NO. 2025-105**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, SITTING AS THE GOVERNING BOARD OF THE CITY OF POMONA HOUSING AUTHORITY APPROVING THE ACCEPTANCE OF A HOUSING AND URBAN DEVELOPMENT (HUD) GRANT AWARD, TO RECEIVE FUNDING TOTALING \$492,981, AMENDING THE FY 2025-26 BUDGET BY INCREASING REVENUE ESTIMATES, AND APPROPRIATING FUNDS IN THE SAME AMOUNT**

**WHEREAS**, the U.S. Department of Housing and Urban Development (HUD) has selected the Pomona Housing Authority (PHA) to receive a grant award in the amount of \$492,981 to support the administration of twenty-five (25) Foster Youth Initiative (FYI) Program; and

**WHEREAS**, the FYI Program provides critical funding to housing agencies to support transitional aged youth (TAY) aging out of foster care, including those who are at risk of or experiencing homelessness and have been involved in the child welfare system; and

**WHEREAS**, to administer the twenty-five (25) FYI vouchers, the PHA must receive approval by the PHA Governing Board to accept all grant funding and amend the FY 2025–26 operating budget; and

**WHEREAS**, the PHA must have a Memorandum of Understanding (MOU) between the PHA and Department of Children and Family Services, outlining mutual responsibilities of the parties and evidence a commitment of resources to the FYI; and

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona, sitting as the Governing Board of the Pomona Housing Authority, as follows:

**SECTION 1.** Authorize the acceptance of a grant award from HUD, increasing revenue estimates and appropriating funding to the following accounts:

**SECTION 2.** Authorize execution of a Memorandum of Understanding (MOU) with the Los Angeles County Department of Children and Family Services (DCFS) in accordance with FYI program requirements.

**SECTION 3.** Authorize the Executive Director of the Pomona Housing Authority, or their designee, to execute the agreement, amendment, or other documentation requested for acceptance and implementation of the grant award.

**SECTION 4.** The Authority Secretary shall attest and certify the passage and adoption of this resolution, and it shall take effect immediately upon its approval.
