**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING THE FY 2022-23 CAPITAL IMPROVEMENT PROGRAM (CIP) BUDGET BY ACCEPTING GRANT FUNDS, INCREASING REVENUE ESTIMATES, AND APPROPRIATING \$1,383,000 OF FEDERAL STP-L GRANT FUNDS TO “STREET REHABILITATION – DISTRICTS 4 AND 5,” CITY PROJECT NO. 428-2590-XXXXX-67922, FEDERAL PROJECT NO. STPL-5070(038)**

**WHEREAS**, the project description in the FY 2022-23 CIP Budget for “Street Rehabilitation – Districts 4 and 5,” City Project No. 428-2590-XXXXX-67922, Federal Project No. STPL-5070(038) states that there is Federal STP-L supplemental funding pending approval for the Project; and

**WHEREAS**, the City of Pomona has requested federal aid in the form of STP-L funding for the completion of the Project; and

**WHEREAS**, the Federal STP-L funding program recognizes the project name to be “Street Rehabilitation – Districts 4 and 5,” City Project No. 428-2590-XXXXX-67922, Federal Project No. STPL-5070(038); and

**WHEREAS**, the City Council desires to appropriate \$1,383,000 of Federal STP-L grant funds for the purpose of funding “Street Rehabilitation – Districts 4 and 5,” City Project No. 428-2590-XXXXX-67922, Federal Project No. STPL-5070(038); and

**WHEREAS**, the City of Pomona has allocated the required STP-L matching local funds for said Project.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona as follows:

**SECTION 1.** The City Council hereby amends the FY 2022-23 CIP budget by accepting grant funds, increasing revenue estimates, and appropriating \$1,383,000 of Federal STP-L Grant Funds (428-2590-40875-67922, 428-2590-66196-67922) to “Street Rehabilitation – Districts 4 and 5,” City Project No. 428-2590-XXXXX-67922, Federal Project No. STPL 5070(038).

**SECTION 2.** The City Clerk shall attest and certify to the passage and adoption of this Resolution, and it shall become effective immediately upon its approval.
