SUBJECT: APPROVE AN AGREEMENT WITH BEST DRILLING & PUMP, INC.

FOR POTABLE WATER WELL REHABILITATION SERVICES

RECOMMENDATION:

It is recommended that the City Council take the following actions:

- 1) Approve a maintenance service agreement with Best Drilling and Pump for potable water well rehabilitation services of Well 32 and Well 36; and
- 2) Authorize the City Manager, or designee, to execute the maintenance services agreement (Attachment No. 1) and any amendments or related documents, subject to review by the City Attorney

EXECUTIVE SUMMARY:

The recommended action will approve a maintenance services contract to Best Drilling and Pump, Inc. for well rehabilitation services of Wells 32 and Well 36. Both wells have been in operation since 2004 and now require rehabilitation of the well casing and pumping equipment.

FISCAL IMPACT:

The total fiscal impact of the recommended action is \$799,070. Funding is available in the adopted FY 2024-25 Water Resources Department (WRD) Operating budget (571-8123-53600-00000) for potable water well maintenance services of Well 32 and Well 36.

DISCUSSION:

It is recommended that Wells 32 and 36 be rehabilitated to restore much of their lost production and to extend their useful life. Groundwater wells are a crucial source of water for the City and typically meet 80 percent of customer demands. To maintain reliable water supply, WRD continuously assesses and completes rehabilitation maintenance of its wells to ensure their reliability. When Well 32 and 36 were originally constructed in 1966 and 1996, respectively, they produced 1,875 gallons per minute (GPM), and 2,000 GPM. Since that time these two wells seen a significant decline in their rates of production,835 GPM and 655 GPM.

In accordance with Section 2-993.1 (4) of the City's Purchasing Ordinance, a public notice for an Invitation for Bid (IFB), No. 2025-1012, was posted on PlanetBids on February 20, 2025. The solicitation notified 640 prospective bidders, of which 38 bidders downloaded the bid, which resulted in the City receiving 4 proposals. The proposal from General Pump Company was deemed non-responsive due to submitting an incomplete bid package.

After review of the bid proposals, it was determined that Best Drilling and Pump, Inc. met the minimum qualifications and was evaluated based on their pricing proposal and submitted references. Therefore, staff recommends that the City Council authorize the City Manager to execute the agreement with Best Drilling & Pump, Attachment 1.
