#### A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AUTHORIZING A SIDE LETTER AGREEMENT TO THE 2021-2023 MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF POMONA AND THE POMONA CITY EMPLOYEES' ASSOCIATION CHAPTER OF THE TEAMSTERS LOCAL 1932 (PCEA) IMPLEMENTING A 2.5% SALARY INCREASE

**WHEREAS,** the City Council has the authority to create, classify and assign salary scales/ranges for all City of Pomona classifications;

WHEREAS, on October 18, 2021, the City Council adopted Resolution No. 2021-140 adopting the 2021-2023 Memorandum of Understanding (MOU) between the City of Pomona and the Pomona City Employees' Association Chapter of the Teamsters Local 1932 (PCEA/Teamsters)

WHEREAS, the 2021-2023 MOU Article V. Section A. Salary, includes provisions of negotiated salary increases; and

**WHEREAS**, the City Council authorizes the City Manager to negotiate and enter into a Side Letter Agreement with PCEA/Teamsters to amend Article V. Section A. Salary to add a two and one-half percent (2.5%) salary increase retroactive to October 9, 2022.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona, California as follows:

**SECTION 1**. That the City Council hereby authorizes the City Manager to negotiate and enter into a Side Letter Agreement in "Exhibit A" that provides a two and one-half percent (2.5%) salary increase retroactive to October 9, 2022.

**SECTION 2**. Approve the amendment to the 2021-23 PCEA MOU regarding a two and one-half percent salary increase retroactive to October 9, 2022.

**SECTION 3**. The City Clerk shall attest and certify to the passage and adoption of this resolution, and it shall become effective immediately upon its adoption.

## EXHIBIT A

#### Side Letter Agreement to the 2021-2023 Memorandum of Understanding between The City of Pomona and Pomona City Employees' Association Chapter of the Teamsters Local 1932 (PCEA)

This Side-Letter of Agreement is entered into by and between the City of Pomona and the Pomona City Employees' Association Chapter of the Teamsters Local 1932 (PCEA) and is effective upon the execution of both parties and adoption by the City Council.

WHEREAS, the City realized a budget surplus in fiscal year 2022-2023;

**WHEREAS**, the City extended and the Union accepted a two and one-half percent (2.5%) salary increase. This action by the City Council recognizes the dedication of all current PCEA employees as negotiations for a successor Memorandum of Understanding (MOU) begins.

**WHEREAS**, the City Council approved amending the 2021-23 PCEA MOU, Article V. Section A. Salary to add a two and one-half percent (2.5%) salary increase retroactive to October 9, 2022; and

**WHEREAS**, the City and PCEA met and conferred regarding this increase;

Now therefore the parties agree as follows:

- 1. That the salary schedule for all classifications in the PCEA MOU shall be increased by two and one-half percent (2.5%) retroactive to October 9, 2022;
- 2. That nothing in this agreement shall be considered precedent-setting or establish a past practice;
- 3. All other terms and conditions of the current MOU between the parties shall remain in effect.
