2025

RECOMMENDATION:

It is recommended that the City Council receive and file the City of Pomona Annual Report on Development Impact Fees for Fiscal Year Ended June 30, 2025.

EXECUTIVE SUMMARY:

To comply with the State of California Government Code Sections 66001 and 66006, otherwise known as AB1600 requirements, as amended by AB516, the Finance Department submits the City of Pomona Annual Report on Development Impact Fees for Fiscal Year Ended June 30, 2025,

Pursuant to State Law the Annual Report is to be made available for public review at least 15 days prior to the Council Meeting. On December 1, 2025, this report was filed with the City Clerk's office, posted to the City's website, and made available for public review.

PREVIOUS RELATED ACTION:

On March 17, 2021 the City Council adopted Resolution 2021-57, adopting interim Development Impact Fees, and then on August 2, 2021, the City Council adopted Resolution 2021-89, adopting revised Development Impact and Connection fees, which were effective starting October 1, 2021. This report covers fees collected under both the old fee structure in place prior to October 1, 2021, the interim fees structure in place from May 17, 2021 to September 30, 2021 and the new fee structure, effective starting October 1, 2021.

The most recent City of Pomona Annual and Five Year Report on Development Impact Fees as of June 30, 2024 was received and filed with the City Council on December 16, 2024.

DISCUSSION:

State of California Government Code Sections 66001 and 66006 require local agencies that impose Development Impact Fees to prepare an annual report providing specific information about those fees. Finance hereby submits the annual report on the Development Impact Fees for the City of Pomona, for fiscal year ended June 30, 2025 (Attachment No. 1).

Development Impact Fees are charged by local agencies to applicants in relation to approval of development projects. The purpose of these fees is to defray all or a portion of the cost of additional or expanded capacity for public facilities as a result of development projects within the City. Government Code §§ 6600-66025 (the "Mitigation Fee Act"), most of which was adopted in 1987 as AB 1600, sets forth the legal requirements for enacting a Development Impact Fee program.

The City of Pomona enacted a Development Impact Fee program by adopting Ordinance No. 3506 on August 14, 1989 via Resolution No. 89-200. As mentioned in the previous related actions, the new fee structure adopted by City Council on August 2, 2021 went into effect on October 1, 2021.

The City Council must review the annual report at a regularly scheduled public meeting not less than fifteen days after the information is made available to the public. On December 1, 2025, this report was filed with the City Clerk's office, posted to the City's website, and made available for public review.
